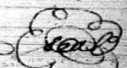


Know all men by these presents that we David Russell and John Russell both of the County of Blount Town of Maryville and State of Tennessee For divers good and sufficient reasons to us known Have hereby nominated constituted and appointed and do nominate constitute and appoint our good and Trusty Friend Richard White of the County of Washington and Commonwealth of Virginia our True and lawful attorney in fact for us and in our names to sell convey and dispose of two tracts of land Granted to the said David & John Russell by the Commonwealth of Virginia The one to John Russell containing about the quantity forty three acres and the one to David Russell about forty one acres be the same more or less adjoining each other lying in the County of Washington in the Commonwealth of Virginia in a neighbourhood called the fork settlement of Holston River joining the lands of James Trimble & William Ryburn Hereby authorizing and empowering the said Richard White to sell and dispose of said tracts of land before described and to make and execute to the purchaser a good and sufficient deed and title for the same and to affix thereto our names and seals Hereby ratifying and conforming whatsoever the said Richard White may do about the Premises as fully and amply as if we the said David and John Russell were personally Present at the doing thereof.  Young colt and her choice of three of my best Cows
 I will to her all her wearing apparel All which
 Personal property I will to her own use & that she have
