To all to whom it may concern: Know ye that I Richard White of the county of Washington and State of Virginia for and in consideration of the Love and affection which I have and do bear unto my daughter Sarah the wife of Jacob Baker of the Town of Chingdon, and for the further consideration of the sum of one dollar to me in hand paid by the said Jacob Baker, the receipt whereof is hereby acknowledged, Do by these presents give, grant, bargain and sell unto the said Jacob Baker and his heirs forever one negro man Slave named James Lynch, one negro girl Slave named Jane, one negro girl Slave named Rachael, and one negro child Slave named Esther, and the future increase of the said female Slaves; which said negro Slaves are at present in the State of Tennessee at my plantation on Watanga in Carter County; also one feather bed and furniture, one Bay mare saddle and bridle & two Cows and Calves. And I do hereby for myself and my heirs Covenant and agree to and with the said Jacob Baker and his heirs to warrant and defend the title to the above Granted Slaves and ^{personal} property and the future increase of the said female Slaves unto the said Jacob Baker and his heirs against the claim or demand of all and every person and persons whatsoever.

It is bargained and agreed upon between us the undersigned, Jacob Baker and Richard White to exchange the within negro Slave James Lynch who is this day redelivered to the said Richard White, for a negro girl slave named Agnes who is this day delivered to the said Jacob Baker.
