In the name of God amen the last will and Testament  
of Thomas Johnston being in very weak conditions but in perfect  
sense and memory praised be God, I do commit my soul to God  
in Jesus Christ who was my creator and redeemer in whom I trust  
to be my saviour to raise me again at the last day in Glory, I do  
commit my body to the Earth from whence it has its first being  
to be decently and orderly buried, and my worldly goods as  
followeth, Inprimis I give and bequeath unto my loving  
Joanna Johnston, all my whole personal estate, leaving thy  
said wife my whole Executrix over all and every part of the same  
only requesting that my said Executrix to give and deliver  
my Countryman Peter Pitts eldest daughter one half of the  
first halving after my decease giving and leaving every part  
of the rest of my estate to my aforesaid wife and heirs and to the  
my last will and Testament, I have set my hand and seal  
the 11<sup>th</sup> day of February 1665.

of Gloucester in the County of Westmoreland in Virginia being  
sick and weak in body but of sound and perfect memory praised  
be god for the same knowing the uncertainty of mans con-  
tinuance in this life doe make this my last will and  
testament in manner and form following VIZ I Surrender  
Commit my soul into the protection of Almighty God  
my creator with an assured confidence to obtaine mercy with  
him through the merits of Iesus Christ my redeemer my body  
I commit to the earth from whence it came to be buried with  
decent and Christian burial in hopes of a glorious resurrection  
that so both soul and body may meet in heaven to the  
glory of God and my own eternal comfort, my temporal  
estate I dispose as followeth, To the child now in the womb  
of my wife (in case it shall accomplish to the age of  
Eighteen years) I doe give and bequeath all the lands  
I doe now enjoy or have any right or title unto in Virginia  
to have and to hold the said child him and assigns forever but  
in case the said child should happen to depart this life  
before the accomplishment of that age then I doe give and  
bequeath all my said lands to my dear wife Sarah Saunders  
her heirs and assigns forever I Then I doe will and devise that  
immediatly after my decease a Just and perfect Inventory  
of all my personal estate be taken of what nature  
or kind soever the same shall be the one moiety or half part  
thereof, I doe give to my said wife and the other moiety  
or half part thereof, I doe give unto my said child to  
be delivered to it by my said wife, when it shall accomplish  
to the age of Eighteen years and in the mean time to remain  
in the custody, protection and management of my said wife

I do now give and bequeath all the lands  
I do now enjoy, or have any right or title unto in Virginia  
to have and to hold the said lands, heirs and assigns forever but  
in case the said child should happen to depart this life  
before the accomplishment of that age then I do give and  
bequeath all my said lands to my dear wife Sarah Maunders  
her heirs and assigns forever. Item I do will and devise that  
immediately after my decease a full and perfect Inventory  
of all my personal estate be taken of what nature  
or kind soever the same shall be the one moiety or half part  
thereof, I do give to my said wife and the other moiety  
or half part thereof, I do give unto my said child to  
be delivered to it by my said wife, when it shall accomplish  
to the age of Eighteen years and in the mean time to remain  
in the custody, possession and management of my said wife  
and in case the said child happen to depart this life before  
the accomplishment of the said age, and then all the personal  
estate to revert to the use of my said wife her Executors or assigns  
Item I do nominate and appoint my dear loving wife Sarah  
Maunders to be full and sole Executrix of this my last will and  
Testament, Item I do hereby revoke, annul and abolish  
all former Wills by me made, and in particular one writing  
purporting a will now remaining now remaining in the

possession of John Ashton witness my hand the 20<sup>th</sup> of August 1666.

To all Christian people to whom these presents shall come  
I Samuel Carle of Copple parish in the County of Westmoreland  
say greeting in our lord god everlasting Know Ye that I the said  
Samuel Carle for and in consideration of the sum of four thousand  
pounds of good Tobacco and back to me in hand paid the receipt  
whereof I doe hereby I doe hereby Acknowledge have granted bargain  
sold aliened enfeofed and confirmed and by these presents doe  
grant bargain sell alien enfeof and confirm unto Robert Sadwin  
of the parish and county aforesaid three hundred Acres of good lying  
part of one thousand of land granted to my father John Carle  
and by him devised to me and my brother John Carle in Joint  
tenancy and by the death of my said brother is devolved all to me  
the bounds of the said three hundred Acres to begin upon the  
swamp mead adjoining to my dwelling house and so running for  
breadth up the crucke including the plantation and housing where  
Martin Cole now liveth and to extend for its length according to  
the course in the aforesaid patent expressed To have and to hold  
to him the said Robert Sadwin his heirs and assigns forever free  
from any claim of any manner of persons whatsoever either then  
alive by my father John Carle deceased formerly granted to Martin  
Cole aforesaid for a certain term therein expressed and not yet  
expired and further I doe by these presents covenant for myself
