I Ann Spence being very sick & weak in body but in perfect Sense and Memory praised be god, doe make & ordain this my last Will and Testament in manner and form following: First I commit and bequeath my Soul unto the hands of Almighty God that gave it me, and my body to the earth to be decently buried at the discretion of my Executors hereafter named, and as for that little worldly Estate that God hath been pleased to bestow upon me I give and bequeath in manner Following.

Item I give unto my Son Richard Ancknam one Doane Mare, with a blaze in her face called Little Lilly It being for eleven hundred and odd pounds of Tols. left him by my former Husband, Richard Chapman for his Portion:

Item I give and bequeath unto Richard Chapman one heifer near 3 years Old named Taggell, Item I give unto my Daughter Elizabeth Haley one Iron Pott Stone

hogg, and all my wearing cloths, Except myself best gowne, and Petticoat.

Item I give unto Ann Lucas my best gowne and Petticoat, Item I give & bequeath unto my two sons William & Richard Anckram all the rest of my Estate (Viz)

Hogg, Cattle Household stuff with all Debts due to me, to be Equally divided betwixt them they paying my Debts and giving of me Christian like burial, and I leave

as son William Anckram heire and Sole Exor, of this my last Will and Testament

Item I give unto Joshua Hudson a Grind-stone

her last Will and Testament this 29th of August
