Item I return my body to the Earth from whence it was taken to be decently buried at the discretion of my Executors hereinafter named and for what worldly Estate it hath pleased God to bestow on me I give and bequeath in manner and form following, Item I give unto Elizabeth His Daughter of Thomas His and Anne two Cows and two Calves to be delivered to them at the day of her Marriage, Item I give unto my loving Wife Rebecca all my land lying at the head of upper Mactolick River, to her and her heirs Male or Female of that blood forever, and in case that blood be extant, then, to Evan Rice Son of Evan Rice, Item I make constitute and appoint my said loving Wife Rebecca Webb my whole and sole Executrix of this my last Will
