queath unto my daughter Frances Tanner a certain parcel
of land by estimation one hundred and fifty acres begin-
ning upon Edward his line and so running along to the

Land of Major Thomas Vowell being the South South West
line of the grand patent so running the north East line
to the head of Westerly branch of Co. Kennew land that was
and from thence up by the fence where William Martin now
lives up through the great swamp to the Edward line and
to her and her heirs lawfully begotten forever. Item I give
my daughter Frances twelve head of cattle and five ewes
and one ram and two feather and one furniture and
one dark gray mare about four years and one grizzled
son and three barrens and my plow and brass to be all
Iron pots and other how to be divided between my daughter

my decease. Item I do will, desire that my daughter Han-
nah Tanner, may be my full and whole Executrix of this my
