gentle of the other part. Witnesseth that the said Robert Smith
for and in consideration of the sum of ten thousand pounds of silver
to him in hand paid & secured to be paid by the aforesaid John Bush-
rod at or before the unrolling and delivery of these presents the receipt
whereof and every part and parcel thereof he the s^d Robert Smith
doth hereby acknowledge and therefrom doth acquit and discharge
the said John Bushrod his heirs executors & adm^{rs} by these presents
Heath given grants aliened bargained sold enfeoffed and confirmed
and by these presents doth fully clearly & absolutely give grant alien
bargain sell enfeoff & confirm unto the s^d John Bushrod his heirs
& assigns forever all that messuage tenement and tract of land
containing one hundred acres of land being the one half of two
hundred acres lately granted to Henry Dункan and by the proprietors
of the Northern Neck and by me purchased of Charles Dункan & Henry
Dункan it being the Eastermost part of the aforesaid two hundred
acres with all its rights rights members appurtenances together
with all houses buildings orchards gardens lands tenements pastures
hereditaments & appurtenances whatsoever to the s^d messuage or ten-
ement belonging or in any wise appertaining all which said
messuage land and premises are situate lying & being within the
parish of Cople & County of Westm^{ts} and now in the tenour and
occupation of the aforesaid Robert Smith and the reversion and reversions
remainder & remainders of all & singular the before mentioned premises
and also all the estate right title interest use possession property

claims & demand whatsoever of him the said Robert Smith of us or to the same and all debts & writings touching or concerning the premises or any part or parcels thereof. To Have and to hold the said hundred acres of land and all & singular other the premises hereby granted bargained & sold or mentioned or intended to be hereby bargained and sold with their & every of their rights members appurtenances whatsoever unto the said John Rushrod his heirs & assigns to the only proper use & behoofe of the said John Rushrod his heirs and assigns for ever against him the said Robert Smith and all other person & persons whatsoever shall & will warrant & for ever defend by these presents the said Robert Smith for himself & his heirs executors & adms doth covenant promise grant & agree to & with the said John Rushrod his heirs & assigns that he the said Robert Smith his heirs executors & adms or any other person or persons claiming by from or under him or any them shall & will at any time hereafter, at & upon the reasonable request and at the proper costs & charge in the law of the said John Rushrod his heirs & assigns make do perform acknowledge levy execute & suffer or cause to be made done performed acknowledged levied executed & suffered all & every such further act & acts things & things devised devices assurances and conveyances in the law whatsoever for the further better & more perfect assuring & conveying of all & singular the before hereby granted or mentioned to be granted premises with & every of their rights members appurtenances unto the said John Rushrod his heirs & assigns as by his or their Council learned in the law shall be reasonably advised or required. assignes for ever all that piece parcell tenement plantation & tract of
lands situate lying & being in the County of Westmore aforesaid formerly
in the possession of Richard Jenner, deceased and by him sold & conveyed to
Richard Charles of the said County and by him patented in his own name
