Witnesseth, that the said Daniel Morgan as well for the regard which he hath to the said Joseph Lane & George Steptoe as the Consideration of Three Shillings the Receipt whereof he hereby acknowledge Hath, Given, Granted, Allocated, ~~Engaged~~ and Confirmed, and by these Presents Give, Grant, Alien, ~~Engage~~ and Confirm, unto the said Joseph Lane for the use of the Heirs of the said Daniel Tobbs Dec. & Doctor George Steptoe, Two Acres of Land out of the Tract of Land which he drew for two Acres of Land to be laid off on the South side of Tuckers Run and adjoining the Road which said Run, Situate lying & being in the said Parish of Cople & County of Westmoreland; Together with its Appurtenances, and all houses, Out houses, Fences, Ways, Water and Water Courses, & Privies, Remainder & Remainders, Rents, Issues, and Profits of the said Premises and every one thereof, and all the Estate, Right, Title, Property, Interest, Claim & Demand whatsoever of him the said Daniel Morgan, in and to the said Two Acres of Land, hereby Given & Granted. To Have and to Hold the said Land, and Premises hereby Given & Granted unto the said Joseph Lane for the use of the Heirs of Daniel Tobbs Dec. and Doctor George Steptoe their Heirs & Assigns for the only proper use & behoof of the said
