In the Name of God Amen I Jonathan Sandefur of Charles
Parish in York County being Sick and Weak of Body but of Sound and
perfect Sense and Memory Thanks be to Almighty God for the same
do make and Ordain this my Last Will and Testament in manner and
form as followeth

Imprimis I recommend my Soul to Almighty God who gave it -
hoping thro the Merits of my blessed Saviour and Redeemer Jesus -
Christ to receive full remission and forgiveness of all my Sins and
Offences and my Body to the Earth to be decently interred and as to
what temporal Estate the Lord of his Gracious bounty hath been pleased
to bestow upon me I give and bequeath and followeth

✓ Item I Give and bequeath to my loving Wife Constance Sandefur all
my whole Estate of what sort or kind soever during her Natural Life
or widowhood

✓ Item I Give and bequeath unto my Son Gerard Sandefur a Negro boy
called Robin that is to say at or after my Wifes death or Marriage or
before if he thinks proper to give him.

✓ Item I Give and bequeath to my Daughter Elizabeth Inover and my
Daughter Anne Sandefur a Negro Wench called Dinah to be equally

divided between them allowing my Son Gerard to keep the Negro paying to my two Children above mentioned the Value that is to say the Value at or after my Wifes decease or Marriage but in case the Wench having Issue or Increase then my Son Gerard to come in for a proportionable part of such Issue or Increase also in case my Daughter Anne should dye without Issue lawfully begotten then the part of my Estate falling to her to be equally divided between the surviving Children or their Heirs. My Will and devise is that after my just Debts are paid that the residue of my Estate of what sort or kind soever be equally divided between my three Children namely Elizabeth, Gerard and Anne that is to say the Valuation at or after my Wifes decease or Marriage and their Heirs and I do hereby nominate constitute and appoint my loving Wife Constance Sandefur to be my Executrix of this my last Will and Testament In Testimony whereof I hereunto set my hand and affix my Seal this eighth day of February 1756.
