In the Name of God Amen I Thomas Powell of the County of York in Virginia  
being of sound Mind & Memory do make this my last Will & Testament in manner and  
form following My Will and desire is that such Debts as are Justly due from me  
be first and truly satisfied and paid by my Executor hereafter named I give and  
bequeath to my loving Brother Seymour Powell three Negroes by Name Kate  
Hannah & Jenny to him and his Heirs forever Item I lend unto my dear Mother  
Mary Philipson during her Widowhood three Negroes by Name Betty Moll & Nan  
but in case my Mother should marry or depart this Life then I give the three  
Negroes as follows Vizt Item I give and bequeath unto my loving Brother Edward  
Powell one Negro Girl named Betty to him and his Heirs forever Item I give  
and bequeath unto my loving Brother Peter Powell one Negro Girl named Moll  
to him and his Heirs forever Item I give and bequeath unto my loving Brother  
Robert Powell one Negro Girl named Nan to him and his Heirs forever but in  
case either of my Brothers Edward Peter and Robert Powell die before they come  
to lawful Age then my Will and desire is that their Negroes with the Increase be  
equally divided between my loving Brothers John James and Henderson Powell  
my Will and desire is that all my wife's Estate be divided between my dear Mother  
Mary Philipson and my loving Sister Mary Powell Item I give unto my loving  
Sister Mary Powell three Gold Rings to her and her Heirs Lastly my Will and  
desire is that after all my Just Debts and funeral Expences are paid if any  
thing be left of my Personal Estate I give it unto my loving Brother Seymour  
Powell but in case there should not be personal Estate enough to pay the same  
then the said Seymour Powell do satisfy the same out of the above Negroes given to  
him whom I Constitute and Appoint my whole & sole Executor of this my last Will  
and Testament In Witness whereof I have hereunto put my hand and affixed my

I give one Negro Girl named Betty to him and his Heirs forever Item I Give  
and bequeath unto my loving Brother Peter Powell one Negro Girl named Moll  
to him and his Heirs forever Item I Give and bequeath unto my loving Brother  
Robert Powell one Negro Girl named Nan to him and his Heirs forever but in  
case either of my Brothers Edward Peter and Robert Powell die before they come  
to lawful Age then my Will and desire is that their Negro with the Increase be  
equally divided between my loving Brother John James and Hudson Powell  
my Will and desire is that all my Wifes Cloaths be divided between my dear Mother  
Mary Philipson and my loving Sister Mary Powell Item I Give unto my loving  
Sister Mary Powell Three Gold Rings to her and her Heirs Lastly my Will and  
desire is that after all my Just Debts and funeral Expences are paid if any  
thing be left of my Personal Estate I give it unto my loving Brother Seymour  
Powell but in case there should not be personal Estate enough to pay the same  
then the said Seymour Powell do satisfy the same out of the above Negroes given to  
him when I constitute and appoint my whole & sole Executor of this my last Will  
and Testament In Witness whereof I have hereunto set my hand and affixed my  
Seal this second Day of April One thousand seven hundred and forty nine.
