Lorenzo Maxfield and his first wife Quintinia Brummett had four children: Elizabeth was born 1844 in South Carolina and married John C. Lovell, March 27, 1864 in Fannin County, Georgia. Davis was born June 11, 1846 in Fannin County, Georgia. He died August 2, 1921. Davis was married March 22, 1868 to Virginia "Jennie" Knight; she was born August 16, 1852 and died June 23, 1929. They are buried at Mt. Zion Cemetery in Hartman Arkansas. Thomas was born June 30, 1848 in Fannin County, Georgia. He died November 5, 1932. Thomas and his wife "Winney" Emaline Witzel were married March 22, 1868. Winney died Nov. 16, 1926. They are buried at Harmony Baptist Church Cemetery in Fannin County, Ga. Manerva Douthit — record unknown.

Lorenzo Maxfield and his second wife Elizabeth Davis Douthit had three children: Laura was born 1860 and married Thomas F. Elrod, May 28, 1878 in Fannin County, Georgia. Lorenzo Maxfield Jr. was born May 12, 1862 and married Mary Ellen Adeline Patterson on Dec. 2, 1883. They were married at Pearceville, Ga., by William Franklin, M.G. Adeline was born Nov. 27, 1862.

John Harrison Douthit was born April 25, 1867, and died Dec. 5, 1943. He married Rosa Kendrick on Aug. 27, 1892. Rosa died July 25, 1946. They are buried at Mt. Sumach Cemetery, Cisco, Ga.

As the Civil War drew near, Lorenzo Maxfield Douthit Sr. enlisted in the Union Army at Cleveland, Tenn., Oct. 20, 1864. He attained the rank of sergeant in Company G, Regiment 5 and was honorably discharged July 13, 1865 in Nashville, Tenn.

Lorenzo Sr., his wife Elizabeth Davis Douthit and children moved to Alaculsy, Ga., Murray County, shortly after he returned from the Civil War.

Lorenzo Maxfield Jr., the sixth generation of the Douthits in America, his wife Adeline Patterson Douthit, and their children along with the elder Lorenzo Sr. and wife Elizabeth moved from Alaculsy, Ga., to the Little Murray community, then to Cisco, Ga., Murray County. Lorenzo Sr. died on Nov. 25, 1897. His wife Elizabeth died July of 1901. They are buried at Mt. Sumach Cemetery, Cisco, Georgia.

Lorenzo Douthit Jr. was a timber estimator and buyer for C.C. Brownlee Lumber Company, Cisco, Ga. He was the postmaster of Cisco, Ga., and was a member of Woodmen of the World at Cisco. He was also notary public and a justice of the peace. He died Nov. 30, 1911. His wife Adeline died April 2, 1944. They are buried at Mt. Sumach Cemetery, Cisco, Georgia.

Lorenzo Jr. and Adeline Douthit had a family of eight children, four sons and four daughters. Davis Roscoe was born Oct. 22, 1884 in Fannin County, Ga. He died Oct. 6, 1958, and is buried at Mt. Sumach Cemetery, Cisco, Ga. Martha Elizabeth was born May 2, 1889 in Fannin Co., Ga. She died Mar. 22, 1966 and is buried at Mt. Sumach Cemetery, Cisco, Ga. Mary Ellen was born Mar. 6, 1891 in Alaculsy, Ga., and died Sept. 16, 1968. She is buried at Mt. Sumach Cemetery, Cisco, Ga. Annie Mae was born Mar. 27, 1893 in Alaculsy, Ga., and died Feb. 4, 1974. She is buried at Mt. Sumach Cemetery, Cisco, Ga. Lorenso Maxfield III (Mack) was born Feb. 28, 1896 in Alaculsy, Ga., and died Feb. 17, 1977. He is buried at Mt. Sumach Cem., Cisco, Ga. Tina Lee Ethel was born Aug. 4, 1900 in Little Murray, Ga. She died Nov. 5, 1984 and is buried at Old Ocoee Cemetery, Benton, Tenn. Thomas Hill was born Feb. 4, 1902 in

Little Murray, Ga., and died Nov. 20, 1980. He is buried at Mt. Sumach Cemetery, Cisco, Ga. John Price was born July 28, 1906 in Little Murray, Ga. He died May 13, 1976 and is buried at Mt. Sumach Cemetery, Cisco, Ga.

Of the eight children only three married. Lorenzo Maxfield III (Mack) married Ova Stout on May 27, 1922 by Sam Higdon, Cisco, Ga. She was the daughter of Marion Richardson and Sarah Nanna Mae Vaughn Stout. Ova died Mar. 15, 1977. Tina Lee Ethel married John Paul Campbell Jr., Oct. 14, 1936. Thomas Hill married Lois Head on April 16, 1931.

Lorenzo Maxfield Douthit III chose to be known as Mack. He is the seventh generation of the Douthits in America. He worked for C.C. Brownlee Lumber Co., Cisco, Ga.. He was a farmer, a truck driver for Conasauga River Lumber Co., and Rostex Rug Co., from which he retired in 1961. He was a member of Sumach Masonic Lodge No. 55. Ova was a housewife and later worked at Hopple Textile and Rostex Rug Co., which she retired from in 1964. She was a member of the Eastern Star No. 420 Ocoee, Tenn. Both were of Baptist faith.

Mack and his wife Ova had four children, who are the eighth Douthit generation in America. Phyllis Elizabeth was born Aug. 17, 1923 in Cisco, Ga. She was married Apr. 17, 1943 to James William (Bill) Campbell whose birth date was Mar. 31, 1917. He died May 17, 1979 and was buried at Mt. Sumach Cemetery, Cisco, Ga. He served in the U.S. Army during World War II. L.M. Douthit was born Nov. 12, 1926 in Cisco, Ga. He died at the age of 15, Dec. 26, 1941 as a result of a hunting accident. He is buried at Mt. Sumach Cemetery, Cisco, Ga. Florence Wilda was born Feb. 8, 1930 in Cisco, Ga. On April 20, 1956 she married John Roy Brackett; his birth date is Jan. 21, 1925. He served in the U.S. Army during World War II. Marian Maxine was born Sept. 6, 1932 in Cisco, Ga. On April 8, 1955 she married Roy Kersey who was born Feb. 1, 1932 and died Jan. 19, 1973. He is buried at Boanergess Cemetery in Polk County. He served in the U.S. Army during the Korean War. They had one child, Lisa Dawn Kersey, who was born March 23, 1966. She is the ninth generation in America.

Mack and Ova are buried at Mt. Sumach Cemtery, Cisco, Georgia, Murray

## The Daniel Dunn Family

Sir Daniel and James Dunn were of the Great London Company that promoted the Colony of Virginia. Sir William Dunn-Baronet of Dunn and member of the British Parliament, founder of Dunn, Dunraven, and Dunnsville, descended from some of the ancient kings and chiefs of Scotland.

King Charles the First of England granted titles and arms to the Dunns for military services and loans of money which Daniel and William Dunn made to him in 1625. These Dunns were brothers and had sons by the same names who came to Virginia from London.

Daniel Dunn, Sr. was the ancestor that all the Dunns in Murray County, Ga., are descended from. He fought in the Revolutionary War in the early part of 1776 in Captain George McCullock's Company. He was wounded in the war and served 55 days for which he was paid 4 pounds, 2 shillings and 6 pence. We believe he is the son of William who came from England.

Daniel Dunn, Sr. was born in 1761 in Henrico County, Virginia. Rhoda, his first cousin, was born in 1759 and they married in 1781. They had 11 children. They moved early into Tennessee and died in 1821 and 1822.

Daniel Jr. was their fourth child born in 1787 in Greene County, Tenn. He married Susannah Parman, b. 1790 in Kentucky. They moved to Blount County when his mother and all her children moved as a group. Daniel Jr. died in Tuckaleechee Cove, Blount County, Tenn., in 1844. He and Susannah had 12 children. Susannah moved with all but three of her children to Murray County, Ga. She died in 1896 and is buried in Calvary Baptist Church Cem. on 225 N.

William, Daniel Jr. and Susannah's second child, was married and widowed in Blount County. He married 1st Mary Polly Shields, dau. of Arnett Shields and Mary Polly Emett. She was born in 1814 and he in 1812. They had 12 children. She died in 1863. They had a son, Levi, who died in the Civil War.

William married 2nd Martha Briant, b. 1820 and widow of John Caylor. She died in 1865 two weeks after the birth of their first child, William's 13th. They were living in Murray County near Cisco when Sherman Andrew Dunn was born. She is buried in Calvary Baptist Cemetery.

William married 3rd to Lucinda Pace, b. 1845. She died in 1866 after the birth of a child which also died. She is buried at Calvary Baptist Cemetery.

William married 4th to Mary Jane Withers, b. 1843, d. 1895. They had seven children. She had a son at the time of the marriage who also went by the name of Dunn, William is buried at Calvary Baptist Cemetery also. William had 21 children by four wives.

William's nickname was Long Bill. There were a lot of William Dunns in the area so to distinguish between them they were called Short Bill, Blue Bill, Black Bill, and Long Bill.

William and Martha Briant's only child, Sherman Andrew, was born in 1865 and at an early age was partially blind from cataracts. He became totally blind as an older man. He married 1st Sarah Josephine Crumley from Fannin County, Ga. She was born in 1870. They had 9 children. She died in 1911. (1) Maude. (2) Martha m. Noah Fowler, had 13 children. (3) Andrew Sherman m. Lou Dunn, had 11 children. (4) Mark b. 1894, m. Florence Green, Fannin Co., had 7 children. (5) Mary m. Dolph Baxter, had 13 children. (6) Clint died at 7 yrs. of age. (7) Julie m. James Isaac Millsap, had 10 children. (8) James Millard b. 1904, m. Linda Lou Green, had 7 children; d. Jan. 16, 1981. (9) Harold b. 1907, m. Ada Brackett, had 13 children, lives Old Fort, Tenn., last surviving child.

Andrew married 2nd to Laura Dill or Deal. She was born 1868, d. 1960. She is buried in Mt. Sumach Baptist Cemetery, Hwy. 2. Their children: (1) Sherman b. 1913, m. Louise Allen, had 12 children, live in Cisco, Murray County. (2) Laura Ester b. 1916, m. 1st Sidney Davenport, had 6 children; m. 2nd Neal Wheeler, live in Tunnel Hill, Ga. (3) Jim b. 1917, is disabled and lives in rest

home in Dalton, Ga. (4) Mack b. 1923 m. Lillie Mae Crider, have 9 children, live in Tunnel Hill, Ga.

All of Sherman Andrew's first children by Sarah moved out of Murray County into neighboring areas such as Cleveland, Benton, Old Fort, Chattanooga and Rossville, Tenn.

James Millard and Linda Lou Green Dunn moved back to the county after the death of their oldest child, Daniel Richard, b. 1924. Their second child, James Lee b. 1930, who fought in the Korean War, bought the farm where his parents had spend their wedding night 50 years earlier and brought his parents back to Murray County where they died. They were very happy to be back at home at last.

James Millard and Linda had 7 boys, only 4 of whom lived to be grown. The two youngest live in Ft. Oglethorpe. James Lee, the second child, had 4 children. He now lives off Hwy. 2 on Willow Oaks Rd. Three of his four children now live in Murray Co. The youngest, James, graduated from Murray County High in 1982. At present, he is in basic training in the Army. Three of James Lee's children have 2 children each.

This accounts for 9 generations of Dunns from the first Daniel in London, England.

Giles Dunn b. 10-16-1820 Tennessee, d. 3-1-1912 Collin Co., Texas, m. Sidney? b. ca. 1823 Tennessee (she may have been his second wife). Their children: (listed on 1860 census, Cohuttah Springs, M653, No. 132, p. 131): Joseph P. (?) b. ca. 1841, Tennessee (CSA, fought at Chickamauga); William H., b. 11-28-1843 Tennessee; Daniel b. ca. 1846 Tennessee (Union soldier, buried at Vicksburg); Mary b. ca. 1849 Tennessee; Levi b. ca. 1850 Tennessee; Elizabeth b. ca. 1851 Tennessee; Susan S. b. ca. 1853 Tennessee; Etty N. b. ca. 1858 Georgia.

Bought property in 10, 3, No. 122 in 1854 and sold it in 1890 after he moved to . . . Listed at Spring Place in the 1870 census.

William H. (Houston?) Dunn b. 11-28-1843 East Tennessee, d. 11-9-1921 Collin County, Texas, m. Nancy McHaley Carter 3-1-1863 (from Murray County records). Children: Euclid b. ca. 1866 Georgia; Theodocia Ernest (dau.) b. 7-26-1868 Murray Co., Ga. (Other children born after move to Texas and Arkansas.)

Civil War: Enlisted 12-29-1861, according to some reports. May have been in the Battle of Shiloh. Was captured and is prison for 23 months, probably at Ft. Delaware Prison, Ft. Delaware Bay. National Archives send record of a William H. Dunn who enlisted 8-7-1861 in Macon (Co. B, 2 Battalion, Ga. Inf.), but this is probably not the right one.

Moved to Texas about 1869, it seems, but pastored Baptist churches in Georgia after the Civil War (probably Spring Place and Zion Hill churches).
