Midway church in Liberty County, Georgia and was once a pastor of the Presbyterian church in Milledgeville, afterwards becoming a professor in Oglethorpe University. George Camp, born in Connecticut, married Elizabeth Hitchcock, a daughter of E. Hitchcock and descendant of Admiral Foote, Commodore Hitchcock and Commodore Howell of the US Navy. He was a publisher and editor in Utica. In 1815 he removed to

Sacket's Harbor, New York where he established a newspaper, the Gazette, in 1815. Later he was connected with the Sacket's Harbor Bank as president.

George H. Camp of Marietta, son of George and Elizabeth, was born in Utica, New York in 1818. He was raised in Sacket's Harbor. In 1842 he settled in Roswell, Cobb County, Georgia. In 1850 he was married to Miss Jane M. Atwood (born 1830 in McIntosh County), a daughter of Henry and Ann (McIntosh) Atwood.

William James Clay was born 1828 in Washington County, reared on his father's plantation; removed to Cobb County in 1846. He served three years as a Confederate soldier. He was married to Edna Ann Peek Clay of Buffalo Creek, a daughter of James and Mary (Turner) Peck, a native of Taliaferro County. Peck died in 1890, aged 80 years.

Honorable Alexander Stephens Clay, son of William James Clay, was born 1853 in Powder Springs, Georgia and died November 13, 1910 in Cobb County, buried in the City Cemetery in Marietta. Hon. Clay was married to Frances White of Cobb County, in Rights Reserved.

Collins. John Collins of Acworth, Georgia was the progenitor of the family in Hall, Cobb and Paulding Counties. According to his pension record (Revolutionary War

The widow applied on 1/31/1853, aged 82, stating that she was Phebe Sailors and was

married on 11/30/1786 in Burke County, Georgia. John Collins died 3/8/1852 in Cobb

County.

A similar application, that of James P. Collins (R2173), SC Line dated 4/8/1834 from East Feliciana Parish, Louisiana, aged 70, stated that he enlisted in York District, South Carolina and in 1785 removed to Georgia. In 1810 went to Tennessee and in 1820 to St.

Lincoln County, North Carolina. He was married to Mary Anderson 3/31/1803 in Georgia according to Elizabeth Hausey who was at the wedding and by her had five children, viz: Susan, wife of Edward Powers; James S.; Sophia; Ann, wife of John Summerville; and Francis, wife of John East, all alive in 1853. Soldier died 4/14/1840.

A search of the Frederick County, Maryland records did not disclose much on Collins in the 18th century.

He was married on 8/20/1855 in Paulding County to Elizabeth Bone (born 1840 Madison County), a daughter of Bailey Bone and Nancy Evans Bone. After his death, Elizabeth married Isaac Pace on 1/24/1896 in Paulding County. They were all buried in the Mt. Olivet Cemetery, Dallas, Georgia and Dallas City Cemetery. Issue:

Daniel C. Collins, merchant, born 6/13/1813 in Georgia, died 8/8/1890, buried in Mars Hill Cemetery in Acworth. Wife, Isabella, born 1826, died before 1860, buried in Mars Hill without any dates. He married secondly Mary F. (born 1841 in Georgia) and had another whole set of children. Daniel apparently had a substantial farm as it was value at \$7,000 in 1850. On 11/10/1875 Daniell Collins deeded to John S. Collins for \$550, land in the 20th district, second section of Cobb County according to the plan of distribution as being the northern half of Lot 224, 80 acres. Signed David Collins (however deed reads in several places Daniel Collins). In Cobb County Deed Book I, page 149, Daniel Collins deeded to Mrs. J. F. Young on 11/16/1885 lots 224 and the south half of lot 223 in the 20th district, 2nd section of Cobb County, being 240 acres. Issue:

I have the endorsement and support of the Bar and Circuit with very few exceptions. Four-fifths of the Marietta Bar have asked me to run again....Since I have been in Office, I have tried to look after the interests of the taxpayers. I have Undertaken to press the business with as little expense as possible... I was elected Solicitor-General, and in 1889, when I could have been re-elected, I stepped down and out. At the death of Judge Winn, by the unanimous wish of the Circuit, I was elected Judge. I have been elected

Before Gober was re-elected by staggering proportions during the fall of 1900, he sat judge over the highly publicized and emotional assault trial of the Negro man, Sam Robinson. No too long since, the public had lynched a Negro for assaulting a white woman.

Judge without opposition since...." The Marietta Journal. April 19, 1900.

"Sam Robinson will not be lynched. As long as the people have placed the duty upon me, I intend to uphold and enforce the law," he told The Marietta News.

Judge Gober consulted with Governor Candler who agreed that Cobb County did not need another lynching and ordered Robinson remanded to the Fulton County Jail for safekeeping. Meanwhile, Judge Gober set his trial date for Friday morning at 8 o'clock in Marietta. Governor Candler agreed to send Robinson to Marietta on a special train under the protection of the State Military Troops. Six detachments of the Fifth Georgia Regiment and a squad of the Governor's Horse Guards under the command of Major Barker, disembarked at the Powder Springs crossing from the special train on Friday morning at 8: 30 a.m. and marked through the streets with the prisoner handcuffed in their midst. Thousands of curious spectators flocked into the streets and followed Sheriff A. A. Bishop and Bailiff Randy Brewer with their prisoner in tow.

As they reached the court house, guards prevented the crowd from coming inside the court house. The trial was held immediately without public scrutiny. Two attorneys had been appointed the day before to defend Robinson, Colonel J. Z. Foster and Colonel E. W. Frey. As soon as Robison arrived, they had a conference with him to prepare the defense. The jurors selected were: Messrs. J. D. Fagan, George W. Grogan, J. M. Allen, Sr., R. P. Griffin, J. H. Pharr, J. D. Hardage, W. L. Sessions, A. H. Talley, A. J. Stewart, P. C. Carnes,

Robinson was accused of assaulting in a brutal and savage manner Mrs. Ida Inzer, the wife of George A. Inzer, farmer, whom he met on the public highway as she was returning home from a visit to a neighbor near Melvora in Cobb County on Monday afternoon, August 6, 1900.

The first witness was the assaulted Mrs. Inzer who identified Robinson as having brutually assaulted her and that afterwards, she was frightened, screamed, ran and fell while he ran away. Other miscellaneous witnesses testified that they saw him on the same highway. Dr. Moore testified of Mrs. Inzer's wounds, saying that rocks had caused gashes on her head. Robinson admitted assaulting Mrs. Inzer and begged for mercy, saying

"I am so far guilty; this is the only thing I ever done to bring me into court, and I hope it will be the last. I beg for mercy, he said trembling and sobbing.

It did not the jury seven minutes to render a guilty verdict.

"We find the defendant guilty."

Judge Gober asked Robinson to step forward and if he had anything to say.

"No sir, I only ask for mercy."

The judge pronounced the sentence. Robinson was to be taken to the Fulton County Jail and kept there until Saturday, the first day of September, and then brought back to Marietta and privately hanged between the hours of 10 a.m. and 4 p.m. within one mile of the court house. Robinson was shackled by the sheriff's guards and one hundred soldiers carried him back to Atlanta.

On that fated event a large throng of spectators were present to witness the event. That morning,

as a local newspaper expressed, the sun had been playing hide-and-seek behind threatening clouds all morning, and suddenly leaped from behind its fleecy curtain to flood the earth with the golden glory of its mid-day effulgence. "A big black bulk shot downward with the rapidity of the lightning's flash and hung suspended in mid air in the agony of death – Sam Robinson had paid the full penalty of the law for his fiendish assault upon the person of Mrs. Inzer, at Melvors, in this county, on August 6th."

the Marietta fire department. At 9:45 a.m. almost every conceivable kind of firearms were marched down Atlanta street to the Confederate cemetery crossing, about three squares from the court house. People stood on the adjacent hillsides listening to the 10 a.m. train whistle

announcing Robinson's arrival. When the train stopped, the sheriff with his prisoner, accompanied by Colonel J. Z. Foster and guards, was put into a wagonette. The gallows had been

erected on College hill by Mr. C. E. Henderson. When Robinson saw them, he became afraid.

While enroute to the gallows, Robinson talked freely to the sheriffs and his lawyer, and smoked a cigar which someone lit and handed him. They soon arrived at the site of the scaffold. Two colored preachers ascended the scaffold and arranged themselves on the platform. At this juncture, the east side of the enclosure gave away and fell heavily to the ground, leaving the gallows and the doomed man exposed to full view of the crowd. Rev. Paris stepped forward and in a quivering voice read a chapter from the bible and turned and grasped Robinson by the hand asking if he was ready to die. Robinson said that he was. Rev. Bonds came forward and offered a fervent prayer to God for the salvation of the condemned man. After the prayer, Robinson shook the preachers' hands and told them "good-bye", expressing the hope that he would meet them in

"Let me tell you, friends white and colored, never commit the crime I have. Woe be Unto the man who commits it. Teach your children never to commit it. If I had not Committed it here, I would have somewhere else. It is all over here I want to meet you All in heaven. I committed the crime and I don't deny it here and won't deny it in heaven. I just want to pass away."

heaven. Robinson was then asked if he desired to make a statement.

His voice did not quiver and he watched the officers tighten the leather straps around his lower limbs and was led out onto the trap where the rope was placed around his neck. The knot was adjusted at the left ear and a black cap drawn over his head. Robinson turned his eyes towards heaven, as if in mute appeal, and then the cap was pulled over his eyes. Sixteen minutes later Robinson was pronounced dead.



He died December of 1843 in Macon County, North Carolina.
