CARMICHAEL

Duncan Carmichael, b. 1755, d. 7/3/1834 Stokes Co., N. C., his pension application S 41467 stated that he was 67 yrs. old on 5/11/1822 and drafted in Caswell Co., N. C., Capt. Tillman's Co., Col. Dixon's Regt; that he served in Rev. War in 1780 and 1781 and lived in Stokes Co., N. C. after war. He recd land grant dtd 6/12/1778 for 160 acres on Shaw's Mill Cr., Caswell Co., N. C.

The Court Mts. of Stokes Co., N. C., 1832-36, Tues, 12/9/1834, "Wherein the court makes findings that Revolutionary pensioner, Duncan Carmichael, died July 3, 1834, determines that his heirs at law are, and names special guardian for them: Richard, Lemuel, Mary, William, John, Sarah, Mina and Solomon Carmichael.

The 1790 Caswell Co., N. C. Census lists him in St. David's Dist.,; also 1800 Caswell Co. Census and 1820 Stokes Co., N. C. Census. His pension application first dtd 1819, then 1822, states that he was living with his widowed dau., and her five children. Issue of Duncan follows:
