

CHAFFIN

Joshua Chaffin, listed 1790 Charlotte Co., Va. Census, served in American Revolution; Ens. in Capt. Jenkins Co. 4/23/1778, 2d Lt.; Cumberland Co., Va. deed, Joshua Chaffin to John Chaffin, 200 acres Southam Parish, 6/25/1753, DB 2, P. 40. Cumberland County Order Book 1767-1770, P. 368, "on the notation of Joshua Chaffin, a witness for Standley Chaffin, against Sarah Basham, it is ordered that the said Standley Chaffin pay him 245 pds. of tobacco for two days attendance and once coming and returning 65 miles according to law." LWT of Joshua Chaffin pvd 2/4/1805, Charlotte Co., Va., naming issue: Thomas Chaffin, Isham Chaffin, Anne Hatchett, Easter Scruggs, Sally Cheatham, Joseph Chaffin, Jesse Chaffin, and Rhody Collins. Joshua Chaffin was a son of John Chaffin, LWT dtd 6/26/1767, pvd 1/25/1773 Cumberland Co., Va. naming: Joshua, Joseph, Rachel Smith and Ruth Bradley (his son, Christopher d. 1767 Cumberland Co., Va.)

Isham Chaffin, s. of Joshua, b. ca 1750/60, Prince Edward Co., Va., d. Wilkes Co., Ga., LWT dtd 5/2/1822, pvd 8/26/1823, m. 1st Betsy Bird, (who d.) 12/8/1778 Prince Edward Co., Va. m. 2d Patience Atkinson, c. 11/5/1764 Va., d. 5/27/1860 Morgan Co., Ga. Revolutionary War Records by Cameron show Isham Chaffin recd pay as soldier in 1776, Capt. John Morton's Co. of Regts, 4th Va., 2 pds. Issue of Isham follows:

It is believed that Joshua Chaffin, b. ca 1775 Va. was a son of Isham, though not listed in his LWT. Joshua drew land 1805 Ga. land lottery, Wilkes Co. Ga. and had various deed transactions with John Chaffin, above, in Wilkes. Listed 1820 Jasper Co. Census, drew land in Walton Co., Ga., 1/22/1830, while resident of Jasper Co. as follows: Walton Co. DB H, P. 305-6, 3/15/1830, "Jasper County," from Joshua Chaffin to Robert Chaffin, 3/15/1830, grants him 100 acres in Walton Co. He d. Jasper Co., Ga., after 1831 intestate, no est. record found. His children removed to Walton Co., Ga. Issue of Joshua Chaffin follows:

Chaffin, decd, Joshua Chaffin, admr. 12/2/1861. Joshua and Robert W. give bond 2/2/1861.

V. Lemuel Chaffin, b. 1818 Jasper Co., Ga., listed 1850 Walton Co. Ga. Census, w., Luvica, b. 1819 Ga., issue: Robert C., b. 1845; George E., b. 1847, and William, b. 1850, all Walton Co., Ga.

VI. William Chaffin, Jasper DB A, P. 246-7, Frederic Sessions to William Chaffin, 5/6/1824. Joshua Chaffin was apptd admr. of est. of William Chaffin, 1858, Walton Co., Ga. He was b. Ga. 1811, Jasper Co., m. Sarah N. Jones 8/4/1834 Newton Co., Ga., listed 1850 Newton Co. Ga. Census. Issue: John, b. 1834; Martha, b. 1836; Mary, b. 1838; William, b. 1840; Nancy, b. 1843; Joel, b. 1846; and Joseph, b. 1846. His dau., Nancy m. Robert T. Cowen 1/15/1863 Newton Co., Ga.
