William Evans, Jr., b. 1796 Elbert Co., Ga., carpenter, d. after 1850 Elbert Co., Ga. Lived Madison Co. 1820-50, m. 1st Celia Leverett, dau. of John Leverett whose LWT www.georgiapioneers.com names his son-in-law, William Evans. Celia was decd 1850. Howard, DeKalb Co., Ga., on 10/14/1886, having issue: Lawton B., b. 1863; Paul H., b. 1867; Clement, c. 1873 Fulton Co; and Martha L., b. 1880 Fulton Co., Ga.
