His LWT dtd 2/14/1826, pvd 12/19/1826, Putnam Co., Ga., filed V. B, P. 49-50, names wife, Elizabeth H. "and my children." V. E, P. 74, Putnam Co. Returns: "The orphans of Peter R. Gee - Winney and Mary." V. C, P. 234, Putnam Co. Returns, "1829, Frederick Conner, in rt. of his wife and gdn to heirs of Peter R. Gee in full." 12/15/1828, Bond of Frederick Connor and Levi Boswell, names orphans as Edward, Samuel, Jones, David, Robert, Lewis, William and Elizabeth. Elizabeth H. Gee m. 2d Frederick Conner 12/4/1828 in Putnam Co. and were listed on 1830 Putnam Co. Census. Samuel Gee was m. 11/24/1849 Oglethorpe Co. to Elizabeth Jane Bryant and listed on 1850 Clarke Co. Ga. Census. There are also some deeds dtd 1834 in Butts Co. for him. Jones Gee m. Matilda Wright 2/15/1838 Butts Co. Ga. This information comprizes all data available on this family to 1830 in Ga. and it is believed they left the State.

Sara Gee bought from Thomas S. Bailey of Oglethorpe Co., 10/17/1815, 136 acres on waters of Little River in Oglethorpe Co., DB H, P. 441-442.

Henry Gee, b. 1790/1800, owned land in Baldwin and Muscogee counties. Baldwin Co. Returns, V. E, P. 3-6, dtd 1838, "tuition for William Gee, Martha Gee, admx." Baldwin Bk C, Sales, etc., P. 253-4, 9/2/1837, purchasers of est. of Henry Gee, decd, Martha Gee, etc. V., B., Baldwin Invs., Apprs, P. 260-2, "Georgia, Muscogee Co.," appraisement of est. of Henry Gee, 9/2/1837, with notes that Henry Gee had deeds in land lots 263 and 264, 10th dist., Muscogee Co. Muscogee Co. DB B, P. 171, 12/23/1825, Henry Gee to James H. Jones, land in 10th dist, lot 257, Coxes Creek, 114 1/4 acres. Henry Gee was listed on 1830 Muscogee Co. Ga. Census.

James Gee m. Mary Walker of Fayetteville, N. C. and had Henry Gee, b. 1782 Cumberland Co., N. C., d. 1851, w., Martha Elizabeth Forrester who d. 1882, m. ca 1823 Georgetown, S. C., dau. of Bailey Forrester.

Henry Gee and wife, Martha, had Boliver Hopkins Gee, b. 1824 Georgetown, S. C., d. 1888, Planter, lived in Decatur and Mitchell Cos., Ga., m. 5/8/1856 in Decatur Co., Marjorah McKelveen. He was Capt. in Co. A., 59th Ga. Inf., C. S. A., Bainbridge; Major in 1862; also delegate from Decatur Co. Ga. to Military Convention of 1860. Issue: Ella N. Kelly, b. 1860, d. 1929; Mattie Brooks; John S. Gee; Henry A. Gee; Hoppie Joiner; Claude Webb; Ruth West; Minnie Gee; Gustavus Gee; and Charles L. Gee, b. 1879. All data from W. F. Fletcher dtd 8/20/1930, papers at Ga. State Archives in Atlanta.

Drewry Gee m. Ann Glore 5/9/1816 Madison Co., Ga. He received a land grant of 259 acres in Franklin Co., Ga. in 1828 and was listed on 1830 Franklin Co. Ga. Census. Madison Co. DB B, P. 15, 11/16/1817, Drewry Gee to John Beard, town lot No. 35.
