Charles Hall, b. ca 1630, d. 1695 Annemessex, Somerset Co., Md., w., Alice who d. 4/1724 Somerset Co, her LWT naming grandchildren, Richard and Charles Hall, dtd 7/1717, pvd 4/23/1724 Somerset Co. Md. To her gr-dau, Alice, at age of 14, to have personalty, part of which was under care of her son, Richard. Named gr-dau, Sarah Roach, bequeathing 50 acres called "Hopkin's Destiny" on n.s. of Great Annemessex. Her daus, Alice Roach and Mary Banister, extx, residue of est. going to them. The LWT of Charles Hall dtd 6/9/1695, pvd 8/13/1695 Somerset Co. Md. names w., Alice, bequeathing her 50 acres, "Hopkin's Destiny", on e.s. of Chesapeake Bay, and issue: Sarah Curtis, Alice Roach, Rachell Revell, Mary Hall and Charles Hall, son-in-law-William Planer. Old Somerset on the Eastern Shore of Maryland by Torrenc, P. 279, lists Charles Hall among first settlers to Somerset County, from Annemessex, 1661-1662. 1662-1663 Patents of Somerset Co., Md. - "Charles Hall, Hall's Choice, 300 acres, 6/6/1665; entitled to 50 acres of land for coming into Maryland to settle. 1/20/1665. Signed Charles Hall, himself, and Alice Hall." Charles Hall and William Planner appointed Justices to lay out and divide the county into parishes. Issue: Charles Hall, 1665-1709; Sarah Hall, b. 1668 m. James Curtis; Katherine Hall, b. 1670 m. William Planner; Alice Hall, b. 1673, m. John Roach and had dau., Sarah Roach; Mary Hall, b. 1675, m. Mr. Bannister; and Rachel Hall, b. 1677, m. Randall Revell, Jr. and had dau, Alice Revell.

Charles Hall, b. ca 1665, m. 10/31/1693, Somerset Co. Md., Martha Davis, he d. 7/1709, his LWT dtd 12/8/1708, pvd 7/22/1709 Somerset Co. Md., making w., Martha, extrx and dower rights in lands and estates. To sons, Richard and Charles, he gave lands; to youngest sons, William and John, lands, to be sent to school at age 15. Named, dau, Alyes. Overseers: James Curtis, John Roach [bro. in law], Richard Waters. Richard Hall, planter, LWT 12/16/1774, Somerset Co., Md. names his issue: Joshua and Charles. Charles Hall d. 3/1740 Somerset Co. Md. William Hall, LWT pvd 6/1740 Somerset Co., Md. naming issue: Adam, Phenix, Joshua, Ezekiel, William Jurden, Sarah and Hannah.

Charles Hall, b. ca 1690, Somerset Co., M., d. 3/1740. According to Will of John Tuller, planter, Manokin, Somer.Co. LWT dtd 12/13/1729, pvd 1/28/1730, he named w., Ester and following children: John, Joshua, Richard, Stephen, Mary and Ester, testators: Richard Hall, Joy Walstone, John Benson. Charles Hall m. Esther Tull, the dau. of John and Esther Tull, and had: Ezekiel Hall, d. 1778 Somerset Co. Md.; Charles Hall, d. 6/1780 Somerset Co. Md.; Sinah Hall; Sarah Hall; and Leah Hall.

Charles Hall, LWT dtd 6/1780 Somerset Co., Md. naming Polly, Frances, Sarah and Amelia. His w., Mary, LWT 7/1786 Somerset Co., Md. named all children, i. e.: Mary, Dorothy, Isaac, Robert, Elijah, Dorothy's two daus., Elizabeth, Sarah, Frances, Amelia.

Isaac Hall, b. 1765, d. 1813, Rev. War Soldier m. Polly Melson and had six children. Ga. Roster of the Revolution by Knight: "Isaac Hall:, Pg. 334, 416,441. Polly [Mary] Melson, b. 1770, d. 1838, was dau. of Rev. War Soldier, John Melson, who d. Hancock Co. Ga. and his w., Hannah.

Ga., bur. Red Level Cemetery, Wilkinson Co. and had eight children, i. e.: Andrew Allen Cowart; Julia Cowart; Jesse Leroy Cowart, Jr.; Elvina Cowart; Eli Cummings Cowart; Raymond Stanley Cowart, b. 11/19/1869, d. 11/24/1943 m. 5/5/1801 Martha Hatfield, b. 1/25/1885, d. 11/7/1958, and had seven children.

William Oliver Hall, b. 6/29/1842, d. 3/19/1911, Conf. Soldier, Co. I, 3rd Regt, Ga. Vol. Inf., Army of No. Va., m. 12/8/1861 Mary Ann Stuckey, b. 12/22/1843, d. 10/27/1927, dau. of Alexander and Elizabeth Porter Stuckey and had ten children, i. e.: Robert E., b. 1865 of Tifton, Ga. m. Claudie McDuffie [issue: Robert E., Jr., clothier of Atlanta, Ga.; Lulian; Ethel; Kathryn; John; Donald]; Daniel Oliver, b. 1867 m. Lizzie Register [issue: Irene m. Morris Hatcher; Mabel m. Jim Vaughn; Ollie m. Louis Hatcher; Marcus m. Lollie Shepard; Wilma; Lyman]; Donie, b. 1869 m. Mayes; William Oscar, b. 10/27/1873, d. 6/12/1965 m. Eloise Davidson, b. 7/30/1876, d. 4/22/1953, dau. of James and Martha Hogan Davidson [issue: Bertha, b. 11/8/1897 m. Carl Collins; Leevera, b. 2/6/1899 m. John M. Bales; Henry Clarence, b. 10/12/1901 m. Reba Mae Bridges and had 16 children]; M. Alford of Tifton, Ga. m. 2d Bessie Yarborough; Chapel, never md, d. Milledgeville, Ga.; Bee m. Mr. Rurah of Tifton, Ga.; Gordon m. Addie Payne of Wilkinson Co. [issue: Elmer, Addie Mae, Adrian]; Isaac Bishop, b. 1875, d. 1907 m. V. E. Lawson; and Annie E., b. 1871 m. Joel Knight; and Mary Emma m. Raymond Collins.

Lyman Lee Hall, b. 6/10/1844, d. 3/25/1918, m. 11/2/1865, Winnie M. Davison, b. 4/21/1844, d. 3/2/1927, dau. of Allen and Mariah Tomberlin Davidson, and had: Sidney, b. 1866, d. 1911 m. Kizia Beasley; Gertrude, b. 1868, d. 1913 m. J. M. Gilbert; Morgan B., b. 1869, d. 1953, m. 1st Mariah Taylor, 2nd Bessie Fountain Wood; Leila Mary, b. 1872, d. 1873; Leonard, b. 1873, d. 1939 m. Annie Cowe; Carlton, b. 1876, d. Lake Worth, Fla. m. Tennessee Kickliter; Herbert, b. 1878, d. 1935, m. Virgie Smith; Hubert, b. 1878 twin to Herbert, m. Cora Butler; Eunice, b. 1880, d. 1955 m. II. Daniel Melson Hall, Sr., b. 1791, d. 1844, m. 3/16/1826, Polly Keel, Wilkinson Co. Ga., dau. of Noah and Salley Justice Keel. He was Sheriff 1826, Senator 1828-33, Justice of Inf. Ct. 1833-37, trustee of Griffin District Academy. Later removed Marion Co. Ga., bur. Pineville Cemetery.

III. Leah Wingate Hall, b. 2/9/1801 Wilkinson Co. Ga. m. 1st James Hall John and 2nd Hollinger Brown of Stewart Co. Ga.

IV. Elizabeth Jefferson Hall, b. 2/25/1803, d. 12/25/1869, m. William Ezekiel Matthews, 12/5/1826, Wilkinson Co. Ga., b. 1807, d. 1859.

V. Polly Jefferson Hall, b. 1803, twin to Elizabeth, m. Nathaniel Nicholson, also m. William Baskins 2/12/1822, Wilkinson Co. Ga. Removed to Marion Co. Ga.

VI. John Melson Hall m. 11/5/1835 Martha Birdsong.*

VII. David Hall m. Elizabeth Claybourne 12/11/1828 Hancock Co. Ga.

* John Melson Hall, b. 1780, listed on 1850 Wilkinson Co. Ga. Census, w., Mary, b. 1775. Issue: Lydia Hall, b. 1810; James, b. 1820 Ga.

John Hall of Hancock Co. Ga. was b. 1780/90, d. 1840 Hancock Co. Ga., m. Martha Pound, b. 1786 S. C., dau. of John and Mary [Walker] Pound, who d. Washington Co. Ga. after 1870. Hancock Co. DB H, P. 471, John Pound and Mary, his w., of Hancock Co., appoint s., Joel Pound and son-in law, John Hall, both of Hancock Co., to collect and recover from Elisha Walker, David Walker and John W. Smith, admr. of est. of David Walker, decd, our interests in sd est, 12/24/1808. David Walker of Columbia Co. Ga. d. 4/4/1807 [Augusta Chronicle 4/11/1807] and was Martha Hall's maternal gr-father. Issue of John and Mary Walker Pound: Joel, David, Martha, Elizabeth and Mary. John Hall lived on 389 acres on waters of Sandy Run Creek, a branch of Buffalo Creek, Hancock Co., declaring a total of 418 acres Hancock Co. on Sandy Run Creek in 1829 tax digest, and 250 acres in Early Co. Ga. 1830 Hancock tax digest, he declared 8 slaves and 518 acres on Keg Creek, Hancock Co. LWT of John Hall, dtd 8/23/1833, pvd 1/9/1841, Hancock Co. WB P, 487-489. Names children: William Bennett Hall; Martha Hall; Ransom Hall; David Hall; and gr-ch, Catharine and John Wilkins. Issue:

I. David W. Hall, b. ca 1804, m. Elizabeth Clayborne 12/11/1828 Hancock Co. Ga. He purchased land on Buffalo Creek, Hancock Co. 6/19/1829, and is listed on 1830 Hancock Co. tax list, with 185 acres in Washington Co. on Buffalo Creek, one slave. Listed 1830 Census Hancock Co. Ga.

II. William Bennett Hall, b. 11/19/1806 Hancock Co., Ga., d. 2/22/1898, Washington Co. Ga., bur. Long family cemetery, m. Alafair D. Shehee, dau. of Daniel and Alafair [Green] Shehee, b. 1/8/1817, d. 10/12/1889 in Washington Co. Ga., bur. Whiteoak cemetery, m. 10/2/1834 Washington Co. Ga. Issue:

1. Martha Hall m. Alexander Gavin Carswell.

2. Matilda Hall m. Robert Holly Wicker.

3. Augusta Hall m. John C. Williams.

4. John D. Hall m. Elizabeth J. Warthen. Middle Georgia Progress, 11/8/1892 publishes: "Louisville, Ga., Nov. 3. Last night at a political meeting at Brinson's school house, about 9 miles from Louisville, John Hall, a citizen of Washington County, was shot and died in a short time...."

II. Elizabeth Hall, b. ca 1807 Hancock Co., Ga., d. ca 1833 Hancock Co., m. 1/5/1826 Hancock Co., James Wilkins, s. of James and Catherine Wilkins. He was b. 12/1/1805 Hancock Co., d. 11/30/1888 Gregg Co., Tx. Hancock Co. Inf. Ct. Mts 2/6/1826, "James Wilkins, orphan of James Wilkins, came into court and voluntarily made choice of John Hall to be his guardian....", Mts. of Ct., 1817-37, P. 421-422. Minutes of Darien Baptist Church 10/27/1832 show that Elizabeth Wilkins was recd by experience into church membership, and d. bef 8/23/1833, when her father, John Hall, wrote his LWT, leaving two small children, Catharine and John Hall Wilkins. In 1852 the family removed to Rusk Co., Tx, near Kilgore, Tx. Issue:

IV. Martha Hall, b. ca 1814 Hancock Co., Ga., d. 7/25/1838 Hancock Co., Ga. m. 4/12/1838 George W. Davis in Hall Co. No issue. The Southern Recorder, 8/7/1838: "Died at the residence of her father, John Hall in Hancock Co., on the 25th ult., in her 24th year, Mrs. Martha Davis, consort of Mr. George W. Davis. She was the only surviving daughter of her aged parents. Had been married only since April 12th previously."

V. Ransom S. Hall, b. ca 1826 Hancock Co., Ga., d. bef. 1/1854 Hancock Co. Ga., m. 10/2/1845 Hancock Co., America Shivers, dau. of William and Frances B. [Pitt] Shivers, b. 4/26/1827, d. 5/5/1883, Sparta, Hancock Co. Ga. Lived on Fulsom Creek. Listed 1850 Hancock Co. Census. Appl. of William B. Hall, admn. est. of Ransom Hall, decd, appraised 1/13/1854, Hancock Co. Estates, Book S, P. 15. The wid., Mrs. America Hall m. Lorenzo L. Stewart 5/20/1856 Hancock Co., Sheriff., and by him had a dau, Pierce Stewart, b. 5/1860. Before this marriage, she reserved her property including tract in Sparta where she lived, slaves, household goods, etc. coming to her from father, William Shivers, Sr. estate, Hancock Co. DB R, P. 148, 5/20/1856. William Frances Hall, orphan of Ransom S. Hall was put under gdnship of Columbus F. Shiver, 6/4/1860 Hancock Co. Ltrs Gdn. 1860-81, P. 3. The Ishmaelite, 5/9/1883 published: "Dead. Mrs. America Stewart died at her residence in Sparta... She was born on the 28th of April, 1827, and was consequently 56 years and one week old at the time of her death. She was a daughter of William Shivers, deceased, was first married to Mr. Ransome Hall, and after his death to Mr. Lorenzo Stewart...." Issue:
