

George Harper, listed on 1805-6 land lottery, Clarke Co., Ga. His LWT dtd 3/23/1812, pvd 3/1/1813, naming w., Martha and John Harper of Hancock Co., exrs. Listed on 1820 Clarke Co. Census was his son, John W. Harper. Issue of George Harper follows:

Sarah C. Wingo was admx. est. of George W. Harper, Sr., 3/10/1837, Tallapoosa Co., Ala. 2/1837, \$15 pd to J. J. Harper for gathering cattle and furniture; pd. Sarah C. Wingo for feeding horses and boarding three children. 5/29/1840, Sarah C. Wingo gtd to her nephew, George Harper, for love, property in Dadeville, Ala.

Robert Harper, Sr. found Orange Co., N. C. 1753, d. ca 1799 Wilkes Co., Ga., now Taliaferro Co., Hardin Cr. In 1761 he removed to Wrightsborough community in Ga., Wilkes Co. DB GG, P. 27, Robert Harper, Sr. to George Harper, 300 acres on Hardins Cr., 4/15/1789. Issue: I. William Harper, d. 1785 Wilkes Co., Ga., unmd.
