## HOLLAND

The Hollands, descending from the Black Prince of England, migrated to Va. in 1600's, going into N. C. and Ga.

Henry Holland, b. 3/1/1757 Bertie Co., N. C., d. Tattnall Co., Ga. 6/26/1853, applied for his pension as Rev. War Soldier, stating birth, etc., that he entered service in Duplin Co., N. C. 1781 as Militiaman, fighting in Battle of Eutaw Springs; after the Revolution, heremoved to Warren Co. Ga. for four years, thence to Washington, Ga., and in 1799 to Tattnall Co. He was a son of Henry Holland of Bertie Co., N. C., on tax records of 1757, orig. from Nansemond Co., Va. Knight's Roster of the Revolution, P. 418, Henry Holland was on Harvey List of Soldiers, Tattnall Co., and pensioner in 1835. Henry Holland of Tattnall Co. deeds to William Holland of same, 1826, Tattnall DB A, P. 443, land adj. Daniel Holland, et al, 177 acres, also 100 acres. Listed 1820-40 Tattnall Co. Census; in 1804 drawing 200 acres bounty land in Montgomery Co.; 1815 200 acres, Tattnall Co. Issue of Henry Holland follows:

They had one son, Lewis Holland, b. 1828 Tattnall Co. m. 12/31/1849 Caroline Sapp, b. 1829 Tattnall Co. who had David Henry Holland, b. 3/14/1857 Clinch Co., Ga., d. 4/10/1924 Toombs Co., Ga. m. Temperance E. Dukes, b. 7/3/1867 Tattnall Co., d. 11/14/1931 Toombs Co., Ga., the parents of Frances Irene Holland, b. 6/4/1890 Toombs Co., Ga., d. 11/13/1969, Atlanta, Ga. m. 1/2/1910 Shadrick Harrison Stanley, b. 10/29/1884 Toombs Co., d. 7/13/1969, Atlanta, Ga.

## HOLLAND

The Hollands in Ga. descend from those in Nansemond Co., Va., unfortunately, the records in that county did not survive and it is impossible to determine exactly how. Gabriel Holland was the first of the name in Va., he and Richard Holland were massacred by Indians at Berkeley Hundred in 1621.

John Holland of Nansemond Co., was transported in 1664 to the Upper Parish; in 1683 he patented 200 acres at a place called Kinsale. He appears to have had Henry, James, Joseph and John, Jr.

There were four brothers who removed to Georgia about 1812. Lawson S. Holland, b. 1786 Nansemond Co., Va., wife, Elizabeth, b. 1786 Va., were residents of Jasper Co., Ga., listed on 1850 Jasper Co. Census. Lewis C. Holland found in a Japser Co. Ga. deed dtd 9/13/1813, and was included in a lawsuit in Jasper Co. of John Holland, Lewis Holland and Henry J. Holland vs. the Hector Estate. He had a son, Lewis R., b. 1811 Va. Henry J. Holland, b. ca 1790 Nansemond Co., Va., d. 1823 Jasper Co., Ga., m. Margaret Ramsey, b. 1792 Va., sister of Alexander Ramsey who d. before 1820 Jasper Co., Ga. His dau, Letitia, was listed as minor in 1824; and dau., Susan R. Fulton, b. 1814 Va., listed on 1850 Jasper Co. Census with her mother, Margaret, age 58, b. in Va. Bk 4H, Jasper Co. Misc. Ests, P. 146-154, Est. of Henry J. Holland, inv. dtd 1/2/1824, purchasers were L. S. Holland L. C. Holland, Margaret Holland, Joseph Hill, Thomas Mabry, Larey Wekle, Joseph Binford, William Tucker, A. Holland, etc.

William Holland, b. ca 1776 Nansemond Co., Va., removed to Ga. in 1812, as is told by his ancestors. In 1813 and 1814 he was a soldier stationed at Ft. Defiance, in Morgan Co., Ga. He drew in 1820 Ga. land lottery, resident of Jasper Co; drew in 1827 lottery, resident of Monroe Co., drawing land in Carroll Co.; listed on 1820-1825 Clarke Co., Ga. Tax Digest. William d. bef 1830, but it is not known where. However, the 1830 Walton Co. Ga. Census lists a "Widow" Holland. Talton Holland seems to have taken up the land which William drew in 1827 Carroll Co., that is, Lot No. 70, 15th dist., Sec. 5. William's widow may have been Rebecca Holland, who on 12/9/1843, Fayette Co. deeded to Harris Holland, Talton Holland and Susan Holland, 101 1/4 acres, being half of Lot 57, 9th dist. sd co. This same land appears in following transaction: Fayette Co. DB G, P. 8, "Whereas, Talton Holland of Co. of Carroll...and guardian for heirs of Talton and Susan Holland, did commence publication of notice in the Jeffersonian published at Griffin, Ga., that he would, after the expiration of four months, make application...to sell the said estate of the heirs of Talton and Susan Holland... on the first Tuesday in November of 1851...." Issue of William Holland follows:

I. Archibald Holland, b. 1800 Nansemond Co., Va., d. 1868 Paulding Co., Ga., m. 1823 Elizabeth Hagin, dau. of Edward Hagin of Clarke Co., Ga. After this marriage, he left Clarke Co. and settled for a time in DeKalb Co., now Fulton, in present vicinity of terminal station near Rich's in Atlanta. He was a farmer, but cows mired down in muddy bogs, and he searched for other land. About 1830, he owned a blacksmith shop in Atlanta. William Holland, b. 1820 Tattnall Co., farmer, m. Lavenia or Louvicy Youmans 4/30/1845 Tattnall Co., listed 1850-60 Tattnall Census, with widow, Louvicy listed 1870. Issue: Harriett, b. 1846; Lucy, b. 1848; John, b. 1849; Jordan, b. 1852; Lucretia, b. 1854; James, b. 1856. William was decd in 1866.

David Holland, b. 1821 Tattnall Co., farmer, m. Elizabeth Lewis, 4/5/1846 Tattnall Co., b. 1828 Tattnall Co., listed 1850-70 Tattnall Census. Tattnall Co. Ann Retns, 1866-84, P. 226, Inv. of Rights and Credits of minor heirs of W. H. Holland, as returned by David H. Holland, gdn, dtd 4/8/1872. Issue: Ann, b. 1848; Josiah, b. 1849; Berrien, b. 1852; Wealthy, b. 1857; Narcissa, b. 1860; Asbury, b. 1862; Charity, b. 1865; David, b. 1868, all Tattnall Co. Ga.

in Paulding Co., his descendants still retaining this letter. About that time he moved his family to High Shoals, settling near High Shoals Baptist Church, this area being named "Huntsville". Archibald's wife, Elizabeth, d. 12/22/1840 and was buried on the farm, and later Archibald buried beside her in 1868. Archibald m. 2d, Sally Elsberry, a giri 22 years younger. Issue of Archibald follows:

Elizabeth Anderson, dau. of Lucinda Anderson and Edwin Anderson. He was Confederate Soldier for 5th Ga. Vol., enlisting 4/4/1863; and August 3rd same year, d. typhoid fever in Rome, Ga. Buried on father's farm. 5. Henry Holland, b. 8/11/1835 Cobb Co., d. 12/15/1870 Paulding Co., m. Sarah Cariton. When returning home one day, his horse bolted as he turned into the road to his home, lost his seat, his foot caught in saddle and he was dragged down the ravine to the doorstep where his wife disengaged his foot. Henry, severely injured, before he could recover from injuries,

contracted pneumonia, and died. 6. Sarah Annn Holland, b. 8/22/1837, d. 9/12/1910 Paulding Co., Ga., m. 1st Lindsey W. Elsberry 8/30/1857 Paulding Co. having two children by him. During War Between States when all her brothers were away at war, Sarah and her stepmother, "Aunt Sallie", had to care for her father, Archibald, suffering from cancer. After the war, she m. Burrell Marion Camp, a veteran, 4/12/1871, son of Baptist Preacher, Sherwood Camp and wife, Lydia Kennedy. Burrell Camp was Elder of High Shoals Primitive

Baptist Church for 40 years, and had white hair and long white beard. Sarah is buried next to her second husband in the old churchyard cemetery. 7. George Washington Holland, b. 7/15/1839, d. 6/10/1895 Paulding Co., Ga., m. 1st 2/4/1864 Lydia Camp, dau. of Burrell Marion Camp and Mary E. Stegall, and 2d Mrs. Mary Jane Henderson Elsberry. Wash

Holland was blue-eyed, blackhaired, heavy set, about 5 ft 9 in., a Confederate Soldier, enlisting 1861, under command of Capt. J. A. R. Hanks at Camp McDonald for duration of war. In May 1862, he was hospitalized at Chimporazo Hospital, Richmond, Va., for acute diarrhea, released next mo. Wash served under Gen. Lee, was at second battle of Manassas in 1862, wounded on last day of battle; surgeons probed for the ball, deep in his hip, but were unable to remove it. He was captured at Battle of S. Mtn and

Antietam, later paroled at Warrenton, Va. 9/1862. May 1863, wounded again at Battle of Chancellorsville, but proceeded on with Gen. Lee's campaign at Gettysburg, July 1 thru July 3, 1863. He was home in Feb. of 1864 when he married Lydia Camp, but captured 3/31/1865 at Bentonville, N. C. He recd pension as result of wounds after the war. The farm of his father-inlaw, Burrell Camp, was heavily wooded, one mile s.e. of McPherson, Ga., and having no sons to clear the land, swapped farms with Wash Holland. Because of wounds, Wash could only plow for short periods, and his sons did most of the work, Wash spending leisure time reading Bible, and the Cincinnati paper for the Republican news. When his wife, Lydia, lay dying n 1883, two years after birth of their last child, she selected her husband's next wife. Wash's children attended High Shoals and Mt. Olivet schools,

- about a 3-mi. walk. Later, he donated land at Gandy Ridge for a school, helped build it, and boarded the teachers. Issue follows:
