Seorgia Roster of Revolutionary Soldiers by Lucian Lamar Knight, P. 108, Cert. of Elijah Clarke, Col., that Lt. John Kimbrough prays for 287 1/2 acres in Washington Co., 2/2/1784.

John Kimbrough returned to Caswell Co. N. C. and appears to have taken up lands of his father.
