

LAMAR

John Lamar, b. 1740, Revolutionary War Soldier, was Capt. of Ga. Militia, 3rd Regt., during American Revolution. He m. Lucy Appling, her LWT dtd 5/16/1811, pvd 12/15/1822 Columbia Co., Ga. naming daus., Lucy Hill and Martha Lamar, sons, John and Harmony, and son-in-law, Reuben Hill. LWT of John Lamar dtd 5/3/1799, pvd 8/15/1799 Columbia Co., Ga., names heirs: Lucy, Martha, Jackie, William and Harmony.

John Lamar, "Jackie", son of John Lamar, b. 1769 Ga., d. Putnam Co. Ga. 1833, m. his cousin, Rebecca Lamar, dau. of Thomas Lamar. His home was on Little River, near Eatonton, Georgia, and he was known as "Little River John." Issue follows:
