The LWT of William Lee, Sr. dtd 7/7/1870, pvd 12/1870 Bulloch Co., Ga., wherein he names his sister, Sarah Lee; son, James M. Lee, and gr-children: James Frank, Newton R., Ann E. T., issue of his son, John Lee. The LWT of his second wife, Sarah Lee, dtd 5/7/1873, pvd 10/4/1880 Bulloch Co., names her cousin, Martha Foy of Effingham Co, her nephew, Newton R. Lee, her niece, Ann E. Rogers, also James M. Lee and Winfield S. Lee named as trustees. Sarah Lee appears as widow on 1870 Bulloch Co. Census, aged 73, farmer, b. in Ga., and listed with her, Martha, aged 45, b. in Ga. Issue follows:
