## LOGGINS

The name Loggans, Loggins, and various spellings are Scottish, and the family were living in Va. in 18th century. John Loggin made his LWT dtd 1/3/1778, pvd 5/19/1778 Augusta Co., Va. in which he named his children, John, Samuel, William, Robert, Joseph, Sarah, Mary, Alexander and James. Exrs, w. Mary and Mathew Huston.

John Loggins, Sr., b. 10/11/1733 Orange Co., Va., Rev. War Soldier who enlisted in 1777 in 2nd Regt, Va. Line. In his application for a pension dtd 4/1834, he gave his date and place of birth, stating he had lived in Halifax Co., Va., Union Co., S. C., and Pendleton dist., S. C. His son, Samuel Loggins of Hall Co., Ga., made application 1/14/1853 for his

- father's benefits. John Loggins, Sr. stating in his application, "I am acquainted with Messrs. Hugh McDonald, Esq., Charles Smith and John Metter, Esq. He was found on 1810 & 1820 Pendleton dist., S. C. Census. Pendleton DB B, P. 184, 3/17/1792, John Logan of Pendleton district, S. C. to Thomas Stone of same place 200 acres which had been gtd to sd Logan 10/2/1786, heir at law of Thomas Logan, for his services or bounty, being on George's Creek of Saluda River. John Loggin listed 1790 Halifax Co., Va. Census. Issue: I. Samuel Loggins, b. 1760/1770 Halifax Co., Va., listed on 1810
- Pendleton Dist., S. C. Census and on 1830 Hall Co., Ga. Census.
- II. Major Loggins, b. 1764/1784 Halifax Co., Va., listed 1810 Pendleton Dist., S. C. Census. 1800 Census of Pendleton District, S. C., published by Nati Geneal ogical Society: "Major Loggens of Stokes County, North Carolina between 1790 and 2/26/1796, and Charles Clayton witnessed a deed from John Peek to Levi Moore. Majors family was in Stokes County, N. C. as early as 1771. Loggins and Majors families also in Charlotte County, Virginia...James Loggins was in Pendleton district in 1790, Pickens County in 1800. James Loggins, Sr. drew in the 1827 Land Lottery, Hall County, Georgia, Revolutionary War Soldier."

Census. His wid., Mary Loggins, listed on 1860 Hall Co. Census, aged 80, "Pauper with family of Z. Logginswill deorgiapioneers.com
