## MACKINTOSH

Also sp. McIntosh, MacIntosh. John Mor Mackintosh, Jr., Gentleman, Chief of Darien, Ga., b. 1699 Kingussie, Scotland. The Clan came to America with Scottish Highlanders under direction of General Oglethorpe in 1736 to erect a fort south of Savannah, to fight Spanish. The family had recently suffered at the hands of the English in Jacobite Rebellion of 1715 during which Gen. William Mackintosh commanded an army of the Stuart Pretender to the throne of England. The Mackintosh estates confiscated, John Mor Mackintosh, Chiefton, sought refuge at the Altamaha River in Georgia, which he called "New Inverness", now Darien, after their homeland. Four years later, in 1740, just as he was about to return to Scotland to claim his title and estates as head of the Clan, Gen. Oglethorpe militarize an expedition of the Highlanders to go to St. Augustine, Fla. and fight the spanish, during which he was taken prisoner and removed to Ft. Moosa where he was fed only bread and water. About 1741 he was released and returned home. In 1755 he was tax collector of Darien, and probably held other public offices, dying in 1762 at age of 63. He had a grandniece who married George Troup who had Governor George McIntosh Troup of Georgia and the family of Governor Charles J. MacDonald. Issue follows:

- I. George McIntosh, b. 1715 Scotland m. Ann Houston [1723-10/22/1833]. dau. of Priscilla and Sir Patrick Houstoun. Ann died at Cedar Point in McIntosh Co., aged 100 years. Her parents came to America with General Oglethorpe and she was born shortly thereafter at Darien, where Oglethorpe had a military post. She spent her life within ten miles of that place, never having left it but once, when she was expelled by the British. George McInto. was educated, holding positions of honor and trust; surveyor in 1766 and appointed by General Assembly to lay out roads, and in 1768 surveyor for St. Andrew's Parish. The Legislature assigned him jb of laying out town of Brunswick in 1771 which he called "Brounswig." In 1776 he was a Member of the Commons House Assembly, but became unpopular in political circles in 1777 when a proposal was made by Governor John Treutlen to unite South Carolina and Georgia. His contemporaries accused him of collaborating with the British during the war, ie., brining 400 barrels of rice into St. John's River for enemy's use, ultimately resulting in his arrest on 1/8/1777, being placed in irons at Savannah Jail. His brother, Lachlan, angrily fought for his release, finally obtained at 20,000 pds. This incident prompted Lachlan into having a dual with Button Gwinnett, responsible for the arrest. during which they were both shot and wounded, however, Gwinnett having gangrene in his wounded leg, died 5/17/1777, three days after the dual. George's name appeared on Traitor's List published in Ga., and he died in 1779 during seige of Savannah by the British. His brother, Lachlan, desperately tried to recover his titles and estates, but all were confiscated by the British, his personal effects having been sent to his plantation at Sapelo Island by British. His brother, Lachlan, arrested by British during combat at Charleston in 1780, returned home later to find the effects and papers of Gaorge scattered about in unlocked trunks. Land grants and deeds had been placed in a small portmanteau trunk by George's wife, and these were the only valuable assets retained by the family.

Thomas Spalding of Sapelo Island just before the war; Major William McIntosh [Georgia Gazette dtd 6/5/1800 - "Major William McIntosh, son of Colonel William McIntosh, died in McIntosh County]"; and Colonel James Simmons McIntosh, b. 6/19/1787 Liberty Co. Ga., entered army in 1812, wounded at Battle of Molino del Rey, subsequently dying from these wounds. Col. James Simmons McIntosh had issue: General James McQueen McIntosh, Confederate Soldier; General John

Baillie McIntosh of the Union Army; and Capt. J. N. McIntosh. V. Lachlan McIntosh, b. 3/5/1727 Badenoch, Scotland, d. 2/20/1806 at Savannah, Ga., bur. in Colonial Cemetery at Savannah. He was sent to Charlestown by his father in 1748 to work in a counting house to help support his brothers, returning about ten years later to marry Miss Sarah Threadcraf He was Major-General during the American Revolution, a delegate from St. Andrew's Parish to Provincial Congress assembled at Sayannah 7/4/1775. When his brother, George, was arrested, a contest took place between Lachland and Button Gwinnett, already brewing, Gwinnett already refusing to allow General Lachlan McIntosh to fight British forces in Florida, whereby the General called Gwinnett "a scoundrel and rascal". Gwinnett challenged the General to a dual, which took place in streets of Savannah, a short distance

from the Governor's house. While trying to remove George McIntosh's personal effects from the British, Lachlan was suspended from the Continental Congress, and as he was returning to Charlestown in 1780, the city under seige, was captured and imprisoned. In 1784 he was restored to Continental Congress, but his reputation had suffered tremendously. The

- Nephew's in MoIntosh County, Mrs. Caroline P. McIntosh, wife of Hampton McIntosh, age 32, leaving a husband, son and two daughters." Hampton was listed on 1820 census of McIntosh Co., the last known record. 3. General John McIntosh, b. 1754 McIntosh Co., Ga., d. 11/12/1826. m. Miss Sarah Swinton, who d. 1799 St. Simons Island, Ga. He was Lt. Colonel in Rev. War and War of 1812. Dualed with swords with Capt. Elholm,
- nearly severing the captain's right arm. After the war, he settled on St. John's River, subsequently captured and imprisoned by Spanish. Meanwhile, his wife lost her sight, but struggled for her husband's release by writing letters to Governor of Cuba, which she ultimately won. General John was listed on 1820 McIntosh Co. Census. The Southern Recorder published on 11/28/1826: "General John McIntosh died at his plantation in McIntosh County near the place of his birth, on 12th, age about 70 years. He was an Officer in the Georgia Line in 1775 and during the Revolution served with unblemished honor, patriotism and courage. In 1814 he was again in the defense of his country and commanded the Georgia Division which went to Pensacola." Georgia Gazette published 5/17/1792: "Died at Frederica, John McIntosh, son of General John McIntosh."

Princiess and they had a son known as General William McIntosh, Chief of the Creeks, who was murdered by the Coweta indians in his home on the Chattahoochee River. Columbian Museum & Savannah Daily Advertiser published 7/25/1818: "At Theacitck Kali near Ft. Mitchell in the Creek Nation on June 14, William S. Mitchell, Asst. Indian Agent, m. Jennett,

the oldest daughter of the celebrated Creek Warrior, General William McIntosh." Other children were: Major William McIntosh of Mallow; Sally

McIntosh, b. 1792, d. 8/5/1795; and George Baillie McIntosh who m. Catherine Hester McIntosh, the youngest dau, of Mrs. Barbera McIntosh of Mallow, the latter published 6/28/1810 in The Columbean Museum & Savanna Advertiser. From The Georgia Gazette published 8/27/1795: "On the 5th at St. Simons Island in Glynn County, Sally McIntosh died, age 3 years, the last surviving child of Major William McIntosh of that place."

The LWT of Lachlan McIntosh of Savannah, Ga. dtd 1/21/1802, Chatham Co., Ga., left to wife, Sarah, land on Dobey Island; his lot on St. James

Square in Savannah and four slaves to his youngest dau., Catherine McCauley Harris, the wife of Charles Harris of Savannah. To his son-inlaw, John Peter Ward, 500 acres on n.s. Newport River in Liberty Co., 240 acres crossing at Turkey Camp on Houstoun's Swamp, 6 miles n. of Darrien containing 200 acres of tide land; 105 acres of pine land at Clapboard Bluff and Catheo Creek; 650 acres of marsh land on McKithan's Island opposi Broughton Island, 5-6 miles from Old Darien; 200 acres on Cumberland

Island in Camden Co.; 35 acres adj. East Common of Sayannah which he bought at Sheriff's Sale; and 85 acres on the Augusta Rd. adj. lands of Josep Clay. To his son-in-law, Charles Harris, he left all lands on Skidoway Island in Chatham Co.; land on King St. in Savannah adj. land of Abigail Minis; bounty lands from military grants; 6 negroes. Names sons, George McIntosh and Hampton McIntosh. To his daus, Esther Ward and Catherine McCauley Harris, he left all McIntosh Co. lands "being the most valuable property I possess," the same being the centre of trade of the state... including the Town of McIntoshville called in honor of the memory of my worthy father who was the first inhabitant of that country,"

m. Robert Baillie, Tory, who removed to E. Fla. after Revolution. The Columbian Museum & Savannah Advertiser dtd 12/3/1803: "On the 23rd ult., at her home on the head of the Sapelo River in McIntosh County, Mrs. Mary Ann Baillie died, aged 63 years, Relict of Robert Baillie, deceased, and the only sister of General Lachlan McIntosh. She was born in the same country where she died and was the oldest native of the State anywhere. Her parents and their followers were the first settlers on the Altamaha, south of Savannah." Issue:

 Claudia Baillie. Columbian Museum & Savannah Advertiser dtd 8/30/1806: "Died 24th ult., Claudia Baillie, the daughter of the late Mrs.

Mary Ann Baillie of McIntosh County." 2. Jane Baillie. Southern Centinel & Universal Gazette dtd 4/27/1809: Another member of this same Clan was Donald Mackintosh, who migrated with General Oglethorpe at Darien, Ga., a rriving in 1736 in ship, "Prince of Wales" along with John Mohr Mackintosh and his family, under Capt. Dunbar. Donald was b. 1711 in Scotland, d. 5/9/1801, aged 90. He fought with Gen. Oglethorpe in the Spanish wars and skirmishes. He m. Elizabeth Beatrix McIntosh, the sister of General Alexander McIntosh of South Carolina. Beatrix died at age of 65, on 12/25/1792, the dau. of John MacIntosh b. 1685, Senr., of Dornes, farmer, who died at Darien after 1741 and his

wife, Catherine, b. 1688 [Their issue being Alexander, b. 1727; Beatrix, b. 1730; and William, b. 1723]. Donald came to Georgia as a servant to

John MacIntosh of Inverness. Issue follows:

I. Lachian B. McIntosh, b. 1/3/1761 Darien, Ga. m. 9/5/1798 Elizabeth Stafford of McIntosh Co. who was b. 11/18/1777 and d. 5/18/1807. Lachian was a poet, his autobiography dtd 7/21/1807 and filed at Ga. State Archives in Atlanta. After the death of his wife, he was depressed, writing poetry and having strange, prophetic dreams. His brother, Alexander, concerned over his depression, took his youngest daughter, Elizabeth, to raise. On 12/20/1817 Alexander McIntosh, the elder, deeded to Lachian B. McIntosh, his brother, eleven negroes, 50 acres where he resides, 8 cows, sheep, one third of stock of his cattle intrust for use of his nephews and nieces, Lachian, Eliza, Margaret and Alexander.

The LWT of Lachlan McIntosh dtd 9/23/1823 McIntosh Co., Ga., left his son, Lachlan, three tracts of land in McIntosh Co., each containing 455 acres lying on Savannah Post Road to be divided between Lachlan and his sister, Margaret and sister, Eliza. "I hold two lots in the Town of Darien known as No. 56, containing 93 ft. 3 in. fronting Broad Street; also one other corner lot in Darien fronting on Second Street and 100 feet back,"the rents and profits therefrom to be equally divided between his children. A deed dtd 12/22/1853 McIntosh Co., of Luke Mann ofBryan Co. and wife, Margaret, formerly Margaret McIntosh, and his daughter, Sarah Eliza Mann, for \$300 pd by Lachlan McIntosh, sell unto Lachlan McIntosh, 250 acres, being pt of orig. 750 acres. Lachlan McIntosh, late, known while living as Lachlan B. McIntosh, by his LWT, bequeathed to Margaret, his dau, Margaret Mann, one third of a tract containg 750 acres near Darien Road, a distance from S. New Port Bridge known as "Straw Lachlan."

His LWT dtd 10/16/1883 McIntosh Co., names daus, Lucy Ann, B. 1806 Ga. His LWT dtd 10/16/1883 McIntosh Co., names daus, Lucy Ann, Euphremia E., and Harriet C., to whom he bequeathed homestead of 674 acres and plantation tools, sugar mill, boilers, etc., buggies, horses, and three shares of capital stock in Roswell Manufacturing Co. of Ga. To his granddau., Euphremia, wife of Columbia Proudfoot, he left two cows and calves; and to grandson, Hugh Lachlan Proudfoot, one cow and calf. All other property left to children: Alexander, Lucy Ann, Mary E. Jackson, John N., Ephremia E., Donald R. M., Francis B. Proudfoot and Harriet C. M. Issue follows:

Alexander's LWT dtd 12/20/1817 names his brother, Lachlan McIntosh; nephew, Lachian McIntosh; niece, Margaret McIntosh; nephew, Alexander McIntosh; and niece, Eliza McIntosh. He left so much land to his nephew, Lachlan, that Lachlan McIntosh, declared 1095 acres on the 1852 McIntosh Co. Tax Digest, as well as www.jeonglayoneers.com
