

The progenitor of the Millers of Lancaster Co., S. C. and Hancock Co., Ga. was James Miller, listed on 1790 Lancaster Co. Census. The Missionary, 4/29/1822: "Died suddenly at his residence on Dry Creek in this county, on the 11th inst., Mr. James Miller, in the 99th year of his age. He was born in Northern Neck of Virginia, and removed to this county [Hancock] soon after the termination of the revolutionary war. He was twice married, and has raised twenty children..." His LWT dtd 2/14/1821 pvd 5/13/1822, Hancock Co., Ga. names w., Leannah and 16 children. Exrs, Mark Gouder, Henry W. Latimer, Solomon Miller, Thos. J. Latimer. One s., Alexander, decd, before his father. I. William Miller b. 1759 d. 2/1849, Bible of Abram Miller owned by Robert H. McDowell, Ackerman, Miss. His LWT dtd 2/1/1842, Winton Co., Miss. Listed 1790 Lancaster Co., S. C. Census, lived Greene, Washington, and Jackson Cos., Ga., the latter for 30 yrs, before removing to Noxubee Co., Miss, abt. 1834. Issue:

Hancock Co. DB G, P. 117-118, 1/13/1804, between the Heirs of Alexander Miller, namely: Brice Miller, Gideon Bond, John Bond, and Anderson Comer, adm. est. of Samuel Barron, decd, for Jane Barron, relict of sd Barron, to William Bivins, 287 1/2 acres on Town and Denises Creeks, Oconee River, gtd. Alexander Miller 4/12/1791 by the Gov. of Ga.

The Will of Charles Miller, dtd 10/7/1820, pvd. 1/5/1824, Hancock Co., Ga., names w., Elizabeth, and issue: William, James, John, Mary, and Matilda, WB B, P. 140.
