

Alexander Moss lived Wilkes Co., Ga., 6/3/1788 Isaac McClendon and w., Elizabeth deeding him 400 acres. He d. 1800 Wilkes Co., with Philip Moss, adm. of his est. Alexander Moss lived in what is now Lincoln Co., a mile or two s. of Newford Creek, with some family members buried in Beulah Baptist Church cemetery, now on private land; the church established about 1803, later removed to its present location, n. of Newford Creek, near Elbert Co. line, Wilkes Co. Mts. Of Inf. Ct. 1799-1801, P. 51, 8/1/1800, Garland Lane and John Moss vs. Philip Moss, Caveat against L/A gtd on est. of Alexander Moss, decd. Issue follows:

John Moss, Sr., 5/1/1820 John Moss, Jr. apptd admn. est. of John Moss, Lincoln Co., Ga., his LWT in Lincoln Co. undtd (abt 1811), naming w., Charity and issue: ALSO, James and John Thurmond named as heirs. Warrant of Appr. dtd 4/15/1800, est. Alexander Moss; copy of Note of John Moss, Jr. of Fluvana Co., Va. to John Ware of Goochland Co., Va., 1565 pds tobacco, 6/24/1784. Pd. 10/25/1785 all except 6 pds, which was pd. 2/25/1802 by John Moss, one of admns. of est. of Alexander Moss. Issue follows:

6. Lucy Moss.
7. Hudson Moss. 7/31/1800, Hudson Moss, over 14, chooses John Moss, his bro., as gdn.
8. Elizabeth m. Mr. Palmer.
9. Dau. m. John Stubblefield.
10. Dau. m. Garland Lane.
11. Dau. m. John Connel.

Alexander Moss was born 1771 in Goochland County, Virginia. He was a son of John Moss (1740-1810) who died in Edgefield County, South Carolina. John Moss was married on 11/20/1761 in Hanover County, Virginia to Charity Hughes (she died 1808 or 1818 in Lincoln County, Georgia). I feel confident that John Moss was the father of Alexander, although I did not find a will in Edgefield County, S. C. Alexander Moss resided on Newford Creek in Lincoln County.
