## PHILLIPS

John Phillips was elected Trustee to the Ga. Colony 1/11/1742. In 1743 he went to England to propose two Acts at the Queens Sq., Westminster, to establish tenure of lands in Ga., reducing Quit Rents. 9/7/1762 he was granted 150 acres in St. Paul's Parish; 10/29/1765, granted 100 acres in St. George's Parish, Burke Co. John Phillips lived in Richmond Co., where he d. 1784, with admrs of est, apptd 10/28/1784. His LWT dtd 3/28/1777, names seven children, and w., Ruth, as follows:

- I. George Phillips, on 3/5/1784 deeded to Hezekiah Beall for his pt. of the land Willed by his father, John Phillips, decd, 200 acres, Richmond Co. Ga., Test: Ruthy Phillips. His LWT dated Greene Co., Ga., WB F, P. 277, 1816-41, naming w., Sally, and issue: Jane m., Cullen Cradille; William; Lancellot; Henry; Edwin; George W. and Lewis.

Co. Issue follows:

Nassau Or. In 1772 he petitioned Trustee of Ga. stating he had been in the colony for sometime, had wife, 10 children, and prayed for 100 acres in Wrightsborough Township; petition granted. He built a mill on Kettle Creek, and his bro., Joel, organized a church nearby. The Story of Wilkes Co., by Elizabeth A. Bowen: "Zachariah Phillips built a mill on Kettle Creek...When he was away in the Revolutionary War, his wife was annoyed by the Tories. On one occasion it is said that she had been washing clothes and had hung them out to dry when a Tory came up, and seizing a shirt, started to run off with it....She seized one end of the shirt and the Tory held the other and both pulled...." Zachariah petitioned and was granted 575 acres, Washington
