- Joseph Pike, b. ca 1745 N. H., served under Capt. Michael Watson's Co. of Vols. on Horseback, 1781-1782, S. C. Patriots in the American Revolution by Moss, P. 774. S. C. State Plats grants Joseph Pike 449 acres Orangeburg district 8/10/1793, gtd 9/2/1793. Listed on 1790 Orangeburg Co. S. C. Census. After 1793, Joseph Pike removed to Hancock Co. Ga, where he was found on 1812-3 tax digests, 58 acres on Fort Creek. After his death, this land was deeded by Wm. Maddox, adm. of his est. to James Barnes for \$285. Wm. Maddox apptd adm. est. of Joseph Pike 10/11/1815, Hancock Co. Bk I, P. 219-220, Hancock Invs., Appraisements, etc., Est. of Joseph Pike, late of Hancock Co., deceased, Return filed 3/4/1816, gives pers. prop. to Richard P. Pike and Mrs. Pike Joseph Pike had five daus. and five sons. Issue:
- I.\* William Pike, b. 1777 S. C., listed 1810 Edgefield Co. S. C. Census, next door to Joseph and John Pike. Edgefield Co. D3 35, P. 211, William Pike deeds to John Wable 125 acres on Richland Creek of Little Saluda Riverbeing pt of 500 acres granted to Jacob Smith 3/7/1796, and 25 acres, being pt. of above 500 acres gtd to Wm. Salter, then to Wm. Pike, 3/22/1814. Margaret Pike, w. of William Pike, voluntarily surrenders her claim of dower to this land. William listed 1830 Walton Co. Ga. Census. His w., Margaret, apptd admx of his est. Walton Co. in 1853. Listed 1850 Walton Co. Census, age 73, farmer, b. S. C., and Margaret, age 65, b. Ga.
- II. James Pike, b. ca 1774 S. C., listed 1800-1820 Edgefield Co. S. C. Census, served in War of 1812 as given by S. C. Stub Indent Y-244.
- III. Richard Pike, b. 1794/1804 S. C., listed 1820 Putnam Co. Ga. Census with his mother, Mary Pike. Named in est. of Joseph Pike, Hancock Co. Ga.
- IV. Richard Pike, d. 1819 Baldwin Co., w., Polly, drew for her orphans in 1820 Baldwin Co. Land Lottery. Mary Pike listed 1820 Baldwin Co. Census, b. 1775/1794. He m. Mary Turner 1/7/1805, from Charleston Courier, "both of Charleston". Nathaniel was stucco plaisterer.
- V. Sarah Pike m. Wm. Wormen 1/27/1823 Putnam Co. Ga.
- \*William Pike's w., Margaret, was deed in 1858 when her son, William, received her share for her. Issue: Henry Pike, deed in 1856, m. Ann, b. 1803, listed 1850 Bibb Co. Ga. Census, b. 1804 S. C., m. Ann Bradley 7/8/1840 Bibb Co. and had William and Emma; Matilda m. George W. Duncan 8/11/1828 Walton Co. Ga.; Elizabeth Pike b. 1815/20, m. Robert Rodgers 2/28/1838 Walton Co.; William Pike, b. 1815/20, and one other son.
- VI. John Pike, b. 1760/1770 S. C., in War of 1812, Pvt., John Cheatham's Co. Listed 1800-1810 Edgefield Co. S. C. Census, 1820 Walton Co. Ga. Census; 1827 Fayette Co. Land Lottery, 1830 Coweta Co. Census. He m. 8/24/1836 Elizabeth Davis, Fayette Co., a second marriage. Issue:
- 1. William Pike, b. 1800 Edgefield Co. S. C., m. Bathenia Reeves, b. 1804 Ga., prob. Walton Co. Listed 1820 Walton Co. Census, drew in 1827 Land Lottery, a resident of Fayette Co. Drew 1832 Land Lottery, from

Heard Co., Ga., listed 1830 Troup Co. Ga. Census. He was first found in Fayette Co. deeds 1823, but a deed in that co. shows he was resident of Troup Co. by 1831. Issue follows: a. John Floyd Pike, "Buddy", b. 1828 Fayette Co., Ga., d. aft. 1870 m. Elizabeth Lee. Listed 1850-70 Randolph Co. Ala. Census with Elizabeth Pike, wid., listed on 1880. He served in Co. K. 59th Regt., formerly Co. B, 2d Battn, C. S. A., enlisting as Pvt. 8/25/1862 from Coosa Co., Ala. From the War Records USAGO 12/31/1863-6/30/1864. he was in hospital in Lynchburg, Va., home sick on furlough. b. Gincy A. Pike, b. 10/28/1824, d. 7/30/1890 m. ca 1840, Franklin E. Boyett in Heard Co., Ga. Jasper Reeves Pike and Simpson Pike were sureties on Jincy A. Boyett's bond as admx. of her husband's est., signed 6/29/1861, c. Jasper Reeves Pike, b. 1828 Troup Co., Ga., unmd. He enlisted C. S. A. 2/3/1862 at age of 40 from Talladega, Ala., Co., D. 1st Ala. Inf. Regt. as Pvt. Was captured at Island 10 and Port Hudson, but survived the war. Census records of 1850 Randolph Co., Ala. list him age 22, however. d. Lucretia Pike, b. 1830 Troup Co., Ga. m. Mr. Lipp. e. Simpson Pike, b. 1832 Heard Co., Ga., d. 1/27/1887, m. 1st Sarah, 2d, Nancy Anglin. He served Co. F., 34th Ala. Regt., Manigaults Brigade, Hindman Div., residence shown as Win Creek, Tallapoosa Co., Ala. Issued disability certificate from Quintard Hospital, Griffin, Ga. 7/28/1864, his injury was caused by gunshot wound to scalp. f. Emeline Pike, b. 1834 Heard Co., Ga. m. Mr. Thomas. g. Jemima Adeline Pike, b. 1836 Heard Co., Ga. m. Hilary Herbert Brown, b. ca 1830, d. 12/13/1864, Elmira, N. Y. He served in Co., A., 2nd Battn, Hilliard's Legion, Ala. Vols., Pvt-Sgt. After the Legion was broken up he served in Co. F., 59th Ala. Inf., taken prisoner and sent to Elmira, N. Y. where he d. 12/13/1864, bur. Woodlawn National Cemetery, Grave 1133. h. Talitha T. Pike, b. 1838 Heard Co. m. John W. Cummins, listed 1830 Randolph Co., Ala. Census. i. Samantha Clementine Pike, b. 1839 Heard Co. m. Mr. Foster j. William T. F. Pike, b. 1842 Heard Co., Ga., unmd, died during Civil War. k. Martha M. Bethenia Pike, b. 1844 Randolph Co., Ala. 1. Nancy Pike, b. 1846 Randolph Co., Ala. m. Seaborn Mulkey, listed 1880 Randolph Co., Ala. Census. 2. Stephen Pike, b. 1790/1800 Edgefield Co., S. C., listed 1830 Walton Co. Ga. Census, 1850 Randolph Co. Ala. Joseph Pike undpubtably had two brothers, William Pike and Thomas Pike. William Pike, b. ca 1745 N. H., lived in Beaufort Co. S. C., near the Broad River. He was owner of 136 slaves and must have owned large tracts of land. He may have m. Susannah Winborn, dau, of Susannah and Thomas Winborn who lived just south of Charleston, on Wadmalow Island, between Charleston and the Broad River. The LWT of Mrs. Susannah Winborn of Wadmalow Island, St. John's Parish, Colleton Co., widow. w, of Thomas Winborn, names her dau, Susannah Pike in her LWT dtd 1/1778, pvd 12/23/1780,

During the war, Thomas Pike joined his brother, William Pike. on his plantation, assisting him in running a ferry at Port Royal, across the Broad River. Stub Indents dated 1786 reveal that William Pike was paid for public service rendered soldiers as ferryman at Port Royal Ferry. The 1790 Beauford Co. S. C. Census lists William Pike with 136 slaves. a son and three daus. He was found on 1810 Orangeburg dist. Census.

3/7/1803 he was granted 460 acres by State of S. C. in Colleton Co.

Thomas Pike, b. 1744, N. H., Dancing Instructor and Fencing Master. who lived at Charleston, S. C. until the war began, and fighting taking place within the city; then he removed to his brothers plantation, above, for a time, before returning to N. H. He must have been married, for there is a mention of him in Journal of Mrs. Ann Manigault, P. 209, V. 22, S. C. Historical Magazine, in which she mentioned "Mr. Pike's Ball", and 8/19/1765 ..... Pike's child died." Thomas Pike provided much of the entertainment of the day in Charleston, giving balls and parties, having orchestras, etc., in conjunction with his dancing school. There are Charleston deeds of him in St. Phillips Parish, Berkeley Co., conveying lands in 1768, 1771. His studio was on Church Street, mentioned in S. C. Historical Magazine, V. 70, P. 149-150, 151-152, V. 35, P. 102, 72, 64, the details of which are elaborated upon and are most interesting. One article tells how, at the onset of the war, he was selling his goods,

preparing to leave the city. S. C. Stub Indents also mention Thomas Pike, running the ferry at Port Royal in 1782. After the war, he apparently returned to Charleston for a while, for we find DB D-4, P. 131-2, Charleston, Jacob Bates to Thomas Pike, Dancing and Fencing Master, P/A to handle his affairs, Bates bound for Philadelphia, 4/3/1793. He purchased lands in Edgefield Co. S. C., from ref: DB 2, P. 161-4, 1/3/1788, Wm. Anderson and Rachel, his w. to John Pool, 90 acres on Halfway Swamp, bounded by Thomas Pike, et al. Halfway Swamp Creek runs off the Saluda River, near Newberry Co. S. C. at Ninety Six, now Greenwood Co. Therefore, this could possibly be the land which Joseph Pike owned in Orangeburgh District, later Edgefield Co. Thomas Pike was not listed on 1790 or 1800 Census of S. C., and we find the following from the City Gazette, Charleston, S.C. 1/16/1824: "Died at New London, N. H., Mr. Thomas Pike, age 84, a soldier in the French War, an Officer of the Revolution." New London is in Merrimack Co., N. H.
