

Daniel Prince, b. ca 1730, d. 1793 Union Co., S. C., listed 1790 Union Co. S. C. Census. Wife, Lydia. His LWT dtd 4/1/1793 Union Co., Bk A, P. 11. Issue: William Prince; Joseph Prince, John Prince, Sr. of Union Co., S. C.; and Edward Prince and Richard Prince of Pendleton district, S. C. Richard Prince's LWT recorded Bk A, P. 19, Spartanburg Co., S. C., names Isam, Celia, Sarah, and Elizabeth, as heirs.

Edward Prince, Sr., was b. ca 1755, d. after 1820 Union Co., S. C., listed 1790-1800 Union Co. S. C. Census. He also owned lands in Pendleton dist. 1800 Census of Pendleton District, S. C. by National Genealogical Society, P. 73: "Robert Goodloe Harper was living in Charleston, S. C. in November 1794, when he bought 30 tracts of several thousand acres in Pendleton District from Hugh Middleton and Edward Prince of South Carolina...."

The issue of Edward Prince, Sr., follows:

C. to Edward Prince of Greene Co., Ga. 287 1/2 acres in Washington Co. on waters of Rocky Creek. He had a dau, Betsy Prince who m. James Clark 8/7/1803 Greene Co. Ga.

V. Daniel Prince, b. 1786 Union Co., S. C., w., Sarah, b. 1785 N. C. Removed to Ga. ca 1822 and listed on 1840-50 Morgan Co. Ga. Census. Issue follows:

4. Elisha Prince, b. 1820/1821 Ga., lived Morgan Co. 1850.

5. Reuben Prince, b. 1822 Ga., m. Ann, b. 1828 Ga., lived Morgan Co. 1850. Issue: Mary, b. 1844; William, b. 1846; Reuben, b. 1849, all Morgan Co., Ga.

6. Eliza Prince, b. 1828 Ga.

8. Daniel Prince, b. 1818 Union Co., S. C. m. Martha Allen 6/25/1837 Morgan Co., Ga., listed 1840 Morgan Co. Census; 1850 Henry Co. Census; and 1860 Fulton Co. Census. Issue: A. Prince, b. 1839 Morgan Co.; George W. Prince, b. 1840 Morgan Co. m. Miss N. A. Bowen 8/5/1860 Fulton Co., Ga.; Mary A. Prince, b. 1844 Morgan Co. m. John B. Webb 1/28/1858; Sarah Ann Prince, b. 1845 Henry Co. m. 5/8/1859 Fulton Co.,

William Walter Blackstock; Reuben Prince, b. 1846 Henry Co., Ga. m. Miss M. J. Davis 5/21/1865 Fulton Co. 1870; Nancy Prince, b. 1847 Henry Co.; James Prince, b. 1851 Henry Co.; and Rebecca Prince, b. 1856 Henry Co., Ga. Reuben Prince, b. 1846 was a brick mason and lived in Fulton Co., having a dau., Alice, b. 1866.

Joseph Prince, son of Daniel Prince (b. 1730 d. 1793), was b. ca 1755, and listed on 1830-40 Habersham Co. Ga. Census. Lived in N. C. until after 1800, before removing to Ga. Issue:

I. William D. Prince, b. 1784 N. C., blacksmith, m. Hannah Barton 9/4/1838 Hall Co. Ga., having issue: Alto, dau., b. 1814; J. H., b. 1832; N. W., son, b. 1835; J. F., dau., b. 1838; G., son, b. 1840; W. P., son, b. 1842; A. H., son, b. 1845 and B. F., son, b. 1846.

II. James Prince, b. 1785 N. C., w., Mary, b. 1787 N. C., listed 1830-50 Habersham Co. Ga. Census. Wife, Mary, listed 1870 Habersham Co. Census with dau., Sarah Sellers. Issue: Sarah M., b. 1829 N. C. who m. Mr. Sellers and had issue: Malinda, b. 1859 and Jeremiah, b. 1861; S. E. Prince, dau, b. 1832 N. C.; and E. Prince, dau., b. 1834 N. C.

III. Andrew Prince, b. 1794 N. C., wife, E., b. N. C., listed 1850 Habersham Co. Ga. Census.

IV. Joseph Prince, b. 1802 S. C., listed 1850 Habersham Co. Ga. Census. Lt, Habersham Co. 1822-26, Justice of Inf. Ct. 1842-43, Habersham Co.

Edward Prince, Sr., of Abbeville Co., S. C., b. bef 1755, was listed on 1800 Greenville Co., S. C. Census. Wife, Lucy. His LWT dtd 9/28/1816, pvd 10/3/1818 Abbeville, naming children: Joseph and Edward; grand-dau, Susan Black; son-in-law, Hudson Prince; seven gr-children by name of Clerk, and a bequest to Sally Bavel of \$100. His other children were established by LWT of his son, John W. Prince dtd 11/17/1825 Abbeville Co., S. C. Issue follows:

I. Edward Prince, Jr., wife, Rebecca, his LWT dtd 12/3/1827, pvd 12/17/1827 Abbeville, S. C., naming children: Hugh M. Prince, Polly Clay, Jonathan Prince, Sylvanus S. Prince and Lucy Prince. An Inv. was dtd 1/7/1829, given by A. Maulding and Sylvanus Prince.

II. John W. Prince, his LWT dtd 11/17/1825 Abbeville, S. C., naming six legal heirs, i. e.: Hudson Prince of Pendleton district; Rebecca, the wife of Edward Prince; George Prince of Georgia; Sylvanus Prince, the son of my brother, Sylvanus Prince; Susan, the wife of Robert F. Black, dau. of my sister, Sarah Prince; and Elizabeth Mims, the daughter of my sister, Polly Prince.

III. Joseph Prince.

IV. Dau. who m. Hudson Prince of Pendleton district, S. C.

V. Sarah Prince m. before 1782 Robert F. Black and had dau, Susan Black.

VI. Polly Prince, had dau., Elizabeth who m. Wright Sims before 1782.

VII. Sylvanus Prince, removed to Ga. Inf. Ct. of Jefferson Co., Ga.,

7/19/1799: "Mary Prince, Applicant, Estate of Sylvanus Prince, Caveator, Admx. The Court apptd Mary Prince, extrx, with securities gtd to Moses Newton, Hezekiah Gates. " Mary, wid. of Sylvanus Prince, listed on 1802 tax digest, Jefferson Co. His issue follows:

1. George Prince, drew 1805 land lottery of Ga., from Washington Co. and listed on 1830 Jefferson Co. Census.
