William Reeves, Sr., listed on 1790, 1800, 1810 York Co., S. C. Census, m. in 1793 Elizabeth Thompson, who d. 1822, she apparently a second wife, from various receipts of heirs of William Reeves, Sr. He d. 1818 York Co., Case 45, #1904, heirs receipts given by: J. B. Glover, Hardy Reeves, Mary Thompson, Willis Reeves, E. Glover alias E. Gauden, Wiley Reeves, William Glover, William Reeves. Wiley Reeves, listed 1800 York Co., b. 1760/1770, removed to Jasper Co. Ga. in 1825, 1830 Fayette Co. Ga. Census. Mary Reeves m. William Thompson. Elizabeth Reeves m. 1st James Gauden, 2nd James B. Glover. Lucy Reeves, marr. bond. to William Glover, York Co. S. C. dtd 4/5/1804. Dempsey A. Reeves, listed 1830 DeKalb Co. Ga. Census. Wyatt L. Reeves apptd admr est. Dempsey A. Reeves 1/13/1848 Fayette Co. Ga., appraisers, William & Allen Reeves. Cash paid to W. D. Reeves who m. Sophia A. Champion 1/30/1844 Fayette Co. P. 413, Fayette Co. Returns: "Received of John W. Reeves, guardian of Mary Ann Reeves, orphan of D. A. Reeves, \$5.00 for granting letters, taking bond this 2nd day of Dec. 1849. Wm. J. Russell, C.C.O." Issue of Dempsey A. Reeves: Allen Reeves, b. 1801 York Co. S. C., listed 1850 Fayette Co. Ga. Census, m. Lucretia Williams 2/5/1824 Jasper Co., listed in Fayette Co. deeds 1830, 1835, 1837, 1841, and had: Allen W., Leksster, Wilson C., Lucretia C. and Muntry G.; and Mary Ann Reeves.

I. William Reeves, Jr., b. 1756, w. Nuttey, d. after 1840 DeKalb Co. Ga. His Will dtd 1838 DeKalb Co. Ga. Lived first in Burke Co. The 1840 Pension List shows William Reeves a Rev. War Soldier, age 84. His Will named wife and ten children:

1. George W. Reeves, listed 1805 Burke Co. Ga. Land Lottery.
2. James W. Reeves, w., Sarah, listed 1830-40 DeKalb Co. Census, m. Sarah P. Reeves, 7/29/1838, Jasper Co. His Will dtd 4/29/1852 DeKalb Co. Ga. names w. and ch: Deceased dau., Henrietta Childress [Jane L. Reeve m. 11/24/1842 Jesse Childress, DeKalb Co.]; Gabriel Cone, w. of John H. Cone; Asberry W. Reeves; Polly M., w. of F. I. Wilson; Nutty L., w. of William A. Donaldson whom she m. 11/20/1851 DeKalb Co.; Mahala J. Reeve; William J. C. Reeves and James M. Reeves m. Sarah Ann Baxter 1/13/1853 DeKalb Co. Ga.
3. Elizabeth Reeves m. Mr. Naswood. She was decd in 1838.
4. Jane Reeves m. Mr. Mitchell, decd in 1838.
5. Lucy E. Reeves m. Larkin W. Mitchell 1/5/1842 DeKalb Co. Ga.
6. Nancy Reeves, decd in 1838, m. Mr. Nusom.
7. Noah R. Reeves.
8. Sarah Reeves m. Mr. Donaldson, listed on 1840 DeKalb Census.
9. William D. Reeves, b. 1794 York Co. S. C., m. Camilla M. Cleveland 12/8/1822 Jasper Co. Ga., Camilla b. 1794. Lived Fayette Co. Ga. 1850. Issue: Martha A., b. 1817; Melissa, b. 1834; Letta A., b. 1837; William D., b. 1840; Henry C., b. 1843; Amos W., b. 1845; Robert H., b. 1847; Sarah A., b. 1849, all Ga.

10. Joshua Reeves, b. 1777 York Co., S. C., w., Jemima, b. 1777 S. C., removed to Ga. betw. 1796-1799; Pvt. Ga. State Troops Mounted Infantry in 1813; drew in 1805 Ga. Land Lottery, Burke Co. Ga..

Joshua Reeves later removed to Jasper Co. Ga., found in deed records from 1808 to 1818. In 1819 and 1820 he was in Walton Co. Ga., and 1827 to about 1833 Fayette Co. Ga. Listed on 1850 Tallapoosa Co. Ala. Census. Joshua was named in Will of his father, William Reeves, Jr., in DeKalb Co. Ga. He served on First Grand Jury in Walton Co. 1819, listed 1820 Walton Co. Census; 1827 Land Lottery lists him a soldier, in Landrum's district, Fayette Co., drawing Lot 167, 17th dist. Lee Co. He d. 9/1855 Tallapoosa Co. Ala., with Andrew J. Reeves apptd admr. His children all verified in his estate papers. Issue:

- a. Bethenia Reeves, b. 1804 Jasper Co. Ga. m. ca 1819 William Pike, prob. Walton Co. Ga.
- b. Lurana Reeves, b. ca 1804 Jasper Co., m. James Crosson, 3/14/1824, Fayette Co. At time of her father's death, she lived in Ga.
- c. John Reeves, attorney, b. 1809 Jasper Co., removed to Randolph Co., Ala., leaving a son, Columbus, b. 1833 Fayette Co., who inherited the est. of Joshua Reeves. John Reeves' w., Princess A., b. 1812 S. C., and they were listed on 1840-50 Randolph Co. Ala. Census.
- d. Andrew J. Reeves, b. 1810/1815 Jasper Co. Ga., may be "Jasper" Reeves mentioned in History of Heard County, Georgia, without giving a time period, but as one of early settlers. Andrew was admr. of his father's est. in Tallapoosa Co. Ala.
- e. Levina Reeves, b. 1810/1815 Jasper Co. Ga., m. aft. 1830 to Mr. Evans, lived Randolph Co., Alabama.
- f. Lucretia Reeves m. Irby Chancey, lived Coffee Co., Ala. at time of her father's death.

Another branch of this family stems from Allen Reeves, b. 1755/1774, who d. York Co. S. C. 1808, Vandue List dtd 1/8/1808, admrs., William Reeves, John Reeves, Andrew Heron, Frederick Reeves, Wylie Reeves. His w., Nancy, d. 1812, with Nancy, Lucy and Kezia named as minor children. Seven heirs to Estate of Allen Reeve, i. e.: William Reeves; Nancy Reeves; Keziah Reeves; Lucy Reeves; John Reeves; Nancy Reeves m. David Garrison 1821 York Co. S. C.; Andrew Wilson, d. 1817 Jasper Co. Ga.; and Dudley Reeves. Dudley Reeves, 1818 Jasper Co. Ga. apptd. gdn of Allen Wilson, Polley, Samuel, William, Rebecca, Andrew, orphans of Andrew Wilson.

Jesse Reeves, b. 1760/1775, his Will dtd 6/20/1815, pvd 1/2/1816 Jasper Co. Ga. names bro., Jonathan, w., Sarah L., and issue: David Reeves; Jonathan Reeves, b. ca 1794 m. 9/23/1814 Mary Clark, Jasper Co.; Jeremiah Reeves; Coleman Reeves; Malachi Reeves; Cynthia Brassell; Asenah Mulley; Lettice. *

Hardy Reeves of York Co., S. C., L/A issued to William Reeves 11/8/1809 Admrs. Bond given by Wiley Reeves, William Reeves, Willis Reeves and Thomas Roach. Among those named in the sale were William Reeves, Jr., Avery Reeves, Thomas Roach and James B. Glover. Avery Reeves was found on 1820 Jasper Co. Census, his Will dtd 5/23/1845 Jasper Co., Ga, exrs. James M. Reeves, Joseph H. Reeves. The first deed found for him in Jasper Co. was dtd 8/20/1811, John Moreland to Joel Avery Reeves, 202 1/2 acres on Murder Creek, Lot 31, Bk 4, P. 181-2. Avery Reeves was named in est. records of above Hardy Reeves.

Wyatt Reeves, b. 1770/1780 S. C., listed 1810 York Co. S. C. Census, 1820 Jasper Co. Ga. Census, d. 1828 Fayette Cou. Ga. w., Elizabeth. Jasper Co. deed of Wyatt Reeves to James M. Leroy dtd 1/14/1824 & to Robert Fears 7/8/1825. Bk B, P. 345, Fayette Co. Ga., Elizabeth Reeves, admx. Jesse Matthews, admr. in right of his wife. 1/1/1833 heirs named: Martha C.; Josiah F.; James W.; John W. R.; William A.; Rebecca. Issue:

House of Representatives, 1843.

III. James W. Reeves, b. ca 1817 Jasper Co. Ga., m. Ann J. Mann, 4/8/1838 Fayette Co., Ga. Listed 1840 Randolph Co. Ala. Census.

IV. John W. R. Reeves, b. 1818 Jasper Co. Ga., m. Sophronia E. Reeves 6/7/1849 Fayette Co, b. 1829 Ga. Listed 1840 Fayette Co. Ga. Census, 1850 Randolph Co. Ala. Cemsus. Issue: Mary, b. 1845 Ala; William, b. 1849 Ala.

V. William A. Reeves, b. 1794 York Co. S. C., listed 1820 Jasper Co. Census, 1850 Fayette Co. Census. Inv. of Est. 7/3/1857, Fayette Co., Allen Reeves, admr. Md. 2nd Martha Ann Black 4/30/1835 Fayette Co. Issue: Melissa R., b. 1836; Letta A., b. 1837; William D., b. 1840; Henry C., b. 1843; Amos W., b. 1845; Robert H., b. 1847; Sarah A., b. 1849, all Ga.

VI. Rebecca Reeves, m. Jesse Mathews. P. 345, Fayette Returns, Bk B, Est. Wyatt Reeves, Jesse Mathews, admr. in right of his wife.

Frederick Reeves, d. York Co., S. C., est. dtd 1820, Wylie Reeves, admr., inv. dtd 11/18/1820. "Inventory of property given to Frederick Reeves' children in his lifetime now appraised: Andrew Craig, Thomas Reeves, James Reeves, Wiley Reeves, Hiram Reeves, Samuel Reeves, Arthur Roach."
