The 1799 LWT of William Roberts names: Elizabeth, Isaac, Philip, Nancy, Parish, and Mary.

Joseph Roberts, s. of Richard, b. ca 1750 Granville Co., N. C., d. 1805 Columbia Co., Ga. He witd LWT of Benjamin Harrison dtd 1/17/1773, pvd 5/1774 Granville Co., N. C. Richmond Co., Ga. DB F, P. 148, John Swints of Richmond Co. to Joseph Roberts of Granville Co., N. C. 150 acres of land on Keg Creek 3/4/1791, Joseph Roberts witd a deed of John Armour to Edward White of Savannah, mortg on slaves. Roster of Revolutionary Soldiers in Georgia by McCall, states he m. Winifred Eppinger, b. 7/1/1763, Savannah, Ga., dau. of John Eppinger, b. 5/8/1730 Werender, Wurtenburg, and Barbara Mayers of Savannah. There is a marriage in Wilkes Co., Ga. between Joseph Roberts and Elizabeth Watts dtd 9/3/1793. The w. named in LWT of Joseph Roberts in Columbia Co., Ga. was "Faith," the instrument dtd 1/1/1805, pvd
