James Russell, his LWT dtd 3/12/1831 Henry Co., Ga., Planter, names his wife, Elizabeth; to son, James, 202 1/2 acres, lot 91, 7th dist. Henry Co.; dau., Martha Paul, pt of two lots, one of 30 acres, the other of 15 acres; dau., Leticia, 85 acres on Walnut Creek; son, James, slaves; son, Archibald; dau., Susannah Robinson, slaves; dau., Mary Milling, slaves; dau., Leticia Crew, slaves; dau., Nancy Hamilton, slaves; son, Dr. William Russell. Also names James Crew, son of William and Leticia Crew; James Milling, son of his dau., Mary Milling, widow, WB A, P. 181-185, Henry Co., Ga. Issue follows:

- I. James Russell, his LWT dtd 5/6/1869 Henry Co., Ga., naming his bros. and sisters. Also niece, Mariah Robinson and nephew, James Robinson.
- II. Martha Russell m. Archibald Y. Paul., listed on 1830 Henry Co. Census.
- III. Leticia "Letty" Russell m. William F. Crew, listed 1830 Henry Co. Census, having son, James Crew.
- IV. Archibald Russell. Henry C. Russell, temp., admr, apptd on his est. in Henry Co. Ga. 8/5/1845.
- V. Susannah Russell m. Samuel C. Robinson, listed 1830 Henry Co. Ga. Census, having issue, Moriah Robinson and James Robinson.
- VI. Mary Russell m. Mr. Milling or Millan, LWT of Mary H. Millan, Clayton Co. 1859-1921. She was widow in 1831 at time of father's Will.
- VII. Nancy Russell m. Mr. Hamilton.
- VIII. Dr. William Russell, b. 1794 N. C. m. 2d Lucy Crenshaw 6/9/1829 Henry Co., Ga., b. 1793 Ga. Listed on 1830 Henry Co. Census. Issue: Rebecca Tucker Hunt Russell, b. 1830 Henry Co., Ga. m. 9/10/1846 in Henry Co., John Alexander W. White, b. 1823 Ga. Listed on 1850 Henry Co. Ga. Census, removing to Cass Co., Tx. abt 1857, and was in Lamar Co., Tx. in 1872.

John Russell, 1822-34 Henry Co. Wills and Bonds, P. 228-229, "We, Thomas C. Russell, William Hardin and Jesse Russell, give bond for \$400, heirs jointly to John M. Russell and orphans of John Russell...3/7/1825." Issue:

- I. Thomas C. Russell. Henry Co. DB A, P. 542, 6/14/1828, Thomas C. Benning and Thomas C. Russell, James Sellers, et al, Justices of Supreme Court, a lot containing 4 acres in McDonough, whereon the old graveyard stands, a deed to which said land is acknowledged, sells and exchanges lot in 7th dist. of sd co., being pt. of w. half of lot 155, containing 4 acres. Henry Co. DB A, P. 541, 6/11/1828, Thomas C. Russell to Lucinda Holtzclaw of Henry Co., in consideration of esteem, regard and respect said Thomas C. Russell has for said Lucinda, land on w. side of DeKalb Street in McDonough, eastern pt of lot 11, one acre, fronting DeKalb St by 319 feet.

John Russell of Wilkes Co., Ga., Inv. of his est. 4/27/1808, Bk MMM, Invs., etc., P. 28, sale at house of John Combs. 12/10/1807, Nathan Blackburn was apptd admr. of est. of John Russell, P. 173, Wilkes Mts. of Inf. Ct. He lived on Newford Creek, now Lincoln Co. Ga. His wife, Clarianne Russell, made her LWT dtd 11/25/1820, pvd 6/2/1821 Lincoln

Co., Ga., naming their children. Issue follows:

Thomas Commander Russell m. again in Wilkes Co., 2/6/1812, Sarah Holtzclaw. Wilkes Co. DB GG, P. 253, Thomas Commander Russell to Esther Singletary Starnes, slaves, 10/17/1790.
