The orphans of Alexander Smith drew in Ga. Land Lottery, 1821, land in Fayette Co. Fayette Co. DB A, P. 46, Mrs. Phoebe Smith, wid. of Warren Co. deeds to Alexander Smith of Wilkes Co., for natural love and affection, the land which she drew in the late land lottery, being lot 156 of 4th dist. of Fayette, 8/16/1823. Stephen Smith deeds to Alexander Smith of Fayette Co., 2/6/1826, lot 164, 4th dist., Fayette DB A, P. 395. This Alexander Smith appears to be a son of Capt. John Smith of Wilkes Co., Ga., who lived in that part of Wilkes Co. which later became Warren Co. Issue:

Another Alexander Smith, b. ca 1765, d. 1820 Laurens Co., Ga., came from N. C. to Ga. abt 1791, his wife Martha, prob. Martha Franklin or Hogan. He lived in that portion of Washington Co. which later became Laurens Co. Laurens DB H, P. 169, 12/7/1815, Alexander Smith of Laurens Co., 200 acres. Laurens Co. Retns 1811–23, P. 125, Alexander Smith, decd; Davis Smith, admr. 1/7/1822, with Davis Smith making bond of \$10,000 as admr. of sd est. 7/3/1820. Martha H. Smith, wid., drew in 1821 land lottery, resident of Laurens Co, land lot 222, 12th dist. Monroe Co, which she later deeded to her son, Davis Smith, 4/1/1824, Monroe DB D, P. 15. Her son, Davis Smith, referred to "my Hogan plantation" in his marriage contract, this land in Monroe Co., which may have been his mother's land (above) drawn in land lottery. Martha "H." may have been Hogan, she d. betwn 1825–29 and is prob. buried on old Smith plantation in Monroe Co. Issue follows:

Jeremiah Broxton, and children of dau, Eliza Culpepper and dau, Zelpha Broxton. David Culpepper was one of appres. est. Alexander Smith in Laurens Co. 9/29/1821, and is listed on 1830 Laurens Co. Census. One reference to land belonging to Davis Smith in Laurens Co., mentions pt. of it adjoins est. of Henry Culpepper, decd, also adjoins land of Alexander Smith, decd, deed dtd 1825.

- III. Jeremiah Smith, b. 1795 Washington Co., Ga., d. 1861 Monroe Co., bur. family plot, Monroe Co., m. Milly Bailey 11/26/1826 Bibb Co., listed on 1830-40 Bibb Co. Census, 1850-60 Monroe Co. Census, living next door to Davis Smith family. Only known son: Georgia Messenger, "David Washington Smith, son of Jeremiah Smith, died 6/14/1828 in Macon. aged 9 months. 10 days."
- IV. Elizabeth Smith, b. 1800 Washington Co., Ga., d. 5/1865 Monroe Co., Ga., m. James Hogan ca 1820. 1860 Monroe Co. Census shows Elizabeth Hogan, age 60. Also on 1850 Monroe census with 22 slaves, while Davis Smith lists 77. Also, Davis Smith, in his Will, refers to "My Hogan plantation."
- V. Mable Smith, b. 1/10/1812 Laurens Co., Ga., bur. family plt in Monroe Co. She must have d. after 1830.
- All of the children of Alexander Smith appear to have ended up on plantation of Davis Smith, his son, the ancestor of author. The old house was large two-story frame, built about 1821, with hallway down center of house. An old photograph taken abt 1900 shows slave, called Sarah Low, who refused to leave after the war. Davis Smith raised cotton, owning stores and warehouses. He sent his dau., Jane Smith to Wesleyan Feamel College to study music. Davis Smith visited Charleston to hear Jenny Lynn sing, bringing back the first piano to Monroe Co. Elizabeth Dixon Smith was a talented woman, teaching her children to sing and play the piano. When Gen. Sherman burned his way from Atlanta, some yankee soldiers found the Davis Smith plantation, and Davis Smith climbed a tree to hide from them, however feared they would hear his ticking pocket watch. After the war, the plantation suffered, and around 1900, all of the children had
