

Thomas Stanley, b. ca 1660 England, d. St. Paul's Parish, New Kent Co., Va., came to Hanover Co. Va. before 1686, later St. Peter's Parish. His three children were: Thomas Stanley, Jr., b. 4/15/1688 St. Peter's Parish Register, New Kent Co., Va. and had: Margery, Mary, Thomas, Pleasant, Zachariah, John, Sarah, Anne, Nathan, and Joseph; James Stanley, b. 11/23/1689 St. Peter's Parish Reg., New Kent Co., Va., m. 3/5/1728 Henrico Co. Va. Miss Catherine Hutchins, the dau. of Nicholas Hutchins of Henrico Co. Va. and had: William, James, Mary, Martha, Micajah, Agnes, Strangeman, and Elijah, settled New Garden and Deep River Quaker communities, Guilford Co., N. C.; and John Stanley, b. 10/11/1691 St. Peter's Parish Register, New Kent Co. Va., d. 7/17/1783.
