John Stripling listed on 1790 Franklin Co. N. C. Census, Halifax district, b. ca 1770, d. 1822 Jones Co. Ga., with David Slocumb, admr. of his est. P. 170, Book G, Jones Co. Invs., Apprs., etc., 1/10/1824, receipts of heirs: Aron Stripling; William Stripling; Jacob Palmer; Margaret Stripling; William Parker; Thomas Davis. Issue:

Moses Stripling had eleven children, i. e.: Thomas Stripling, b. 1805, m. 3/23/1826 Sarah Emerson, Jones Co.; Moses Stripling, b. 1810 Jones Co. Ga., m. 2nd Rebecca Emerson 10/6/1853 Jones Co., 1st Rebecca Slocum, 12/1/1836, Jones Co. Ga. Issue of Moses Stripling, Jr.: David M., b. 1840; Francis M., b. 1842; Abel C., b. 1844; Sarah E., b. 1845; James M., b. 1847; Martha A., b. 1849, all Jones Co. Ga.

Polly Stripling, b. ca 1770, m. John Stewart and moved to Calhoun Co., Ala. V. II, Roster of Revolutionary Soldiers in Ga. by Mrs. Howard McCall, P. 115, states that Polly Stripling married John Stewart, a son of Alexander Stewart, the latter being born ca 1753 in Ireland, died Morgan County, Ga. 1810, wife, Elizabeth Barron.

Sarah Stripling, b. ca 1780, m. 1808 Alexander Stewart, Jr., another son of Alexander Stewart, above, Alexander, Jr., b. 4/15/1779, Catawba Indian Reserve, York district, S. C. They had ten children.

Benjamin Stripling, b. ca 1775, m. ca 1790 Elizabeth Stewart, a dau. of Alexander Stewart, Sr., above, and had ten children. They moved to Alabama. Listed on 1820 Jones Co. Ga. Census. One son was Benjamin Stripling, Jr. who m. 12/29/1812 Sarah Ward, Jones Co. Ga.

Henry Co. deed book A, P. 431, "Bibb Co.", 9/17/1823, Moses Stripling of Bibb Co. to Parkes W. Smith, for \$1150, 202 1/2 acres on Indian Creek.

Jones Co. Returns, V. 1, P. 189-90, Elizabeth Stripling, formerly Elizabeth Emerson. Moses, gdn. for Elizabeth. "Received of Moses Stripling, formerly guardian of my wife, Emeline Elizabeth Emerson, daughter of Zachariah Emerson, deceased, \$472.70, minor, wife of David M. Stripling, in full amount...." 4/15/1861./s/David M. Stripling.
