THORNTON

William Thornton, b. 1620 and emigrated to Va. in 1650, when his sponsor, William Pryor, patented land. William Thornton was from Yorkshire, England and settled in York Co., then Gloucester Co. before 1629, where he recd a land grant. Va. Land Patent, Book 5, P. 573. From this grant, he named his plantation "The Hills", after the ancestral estate of his gr-grandfather, Francis Thornton, who d. Yorkshire, England in 1566.

William traded in shipping on Mobjack Bay across the bay from Norfolk, operating the ship "Mary Jane" in shipping to Barbadoes and the West Indies. He died at home of his son, Francis, in 1708 Stafford Co., Va., his tombstone bearing coat of arms, viz: Arms: Argent, a chevron sable, sometimes gules between three hawthorn trees, proper. Crest: Out of a ducal coronet, or a dragon's head, between two wings, argent. Inscription: "God is my hope."

William was m. to Elisia, dau. of Luke Belling or Bellington, and his wife, Elisia Russell Bellington in Lunenburg Parish, Richmond Co., Va., and m. 2d before 1679, Elizabeth Rowland.

In p649 he was gtd 164 acres in Gloucester Co., Petscoe Branch, adj. the land "he now owns". He was elected vestryman from 1677 to 1704, resigning in 1706, his position filled by William Thornton, Jr., who became the Church Warden. A deed in Rappahannock Co., Va.: "William Thornton of Gloucester County, Virginia, of the one part, to Francis and Rowland Thornton, two of the sons of the said William Thornton, deed of gift of land in Rappahannock Co.; goes to son, William, in case one dies. In case of death, again to Esther." Issue of William follows:

I. Edward Thornton, Planter, in 1675 listed as age 29. He m. Patience of Accomack Co., Va. He d. 10/5/1703.

Farnham Parish, WB F, P. 6, Richmond Co., Va.] Luke d. 3/2/1725, his LWT pvd Richmond Co., Va., dtd 1/29/1725, with Ann Thornton, extrx, naming his children: Thomas, Ann Mountjoy, Mathew, Elizabeth Nash, and grandchildren -William Thornton, Sarah Jones and Mark Thornton.

In 1689 Luke Thornton was surveyor in Rappahannock Co., Va.; 1694 he was deeded land in Northern Neck of Va., recorded DB 2, P. 162. Thornton Family, A Partial History, reports births and deaths of above persons, stating children of Luke were: Mark, Rowland, Mathew, Luke, Elizabeth, and Anne. Issue:

Dozier, Mark, Jr., William, and Thomas Thornton left Virginia with their father traveling to Wade, Granville, Bertie, Franklin and Warren Cos., N. C. abt 1764. They were all Rev. War Soldiers, serving under Gen.

Mary Thornton, w. of Mark, was decd in 1858, when negroes belonging to her estate were sold, valued at \$3415.50, recorded 2/2/1858 Jackson Co., by T. A. Thornton, admr. In the distribution of Mary's estate, V. A., Jackson Co. Invs., Appras, P. 630, following distribution was made:

This Indenture made this 19th day of January 1837 between Thomas H. Thornton of the county and state aforesaid of the one part and Mark Thornton of the other part; Witnesseth, that the said Thomas Thornton, for and in consideration of the sum of \$90 in hand paid, hath bequeathed, sold and conveyed all my part of my mother's dower, it being a part of the real estate of Prior Thornton, late of said county, deceased, and I, the said Thomas Thornton, do warrant and defend from myself, my heirs, executors and assigns, and all and every person whatsoever, to the said Mark Thornton..." Jackson Co. DB K, P. 485.
