

John Tomlin of Perquimans Co., N. C., P. 6, History of Perquimans County by Mrs. Watson Winslow, mentions rebel factions of 1677 and 1679, pirates, taking from various persons, including John Tomlin at his plantation. Perquimans Co. DB A, P. 84, John Tomlin of Little River, planter, for "love I bear my sons, John and William Tomlin, do give unto them, six cows each, with increase when they are of age. To daughter, Elizabeth, six cows, two pewter dishes...dtd 1693/94." John Tomlin was gtd 300 acres 7/1694 on Little River, on a branch he named, Tomlin's branch. DB I, P. 30, Jonathan Bateman, etc. to Francis Penrice, 100 acres formerly belonging to William Tomlin, deceased, who died intestate, dated 9/29/1777.

The LWT of John Tomlin dtd 7/7/1715 Perquimans Co. N. C. names his bro., exr, William Tomlin; also, his son, William Tomlin.

William Tomlin, Jr., b. ca 1710, removed to Pasquotank Co. N. C. and had son, Samuel, b. ca 1730, d. Pasquotank Co., N. C., his LWT dtd 1776 naming son, John.

John Tomlin, b. ca 1750 Pasquotank Co., N. C., removed to Burke Co., Ga. ca 1789 where he recd land grant; again in 1790, of 200 acres, Burke Co. The Tomlin's lived in Burke Co. for a good many years, unfortunately, records of that county burned. He apparently died before 1820 Census of Burke Co. Issue:

I. Jacob Tomlin, b. ca 1775, listed 1820-1830 Morgan Co. Ga. Census, d. btwn 1830-40 Morgan Co., Ga. His son, Jesse Tomlin, m. 4/23/1823 Newton Co., Ga., Lydia Sparks; Ensign, Walton Co. Militia 1819-21; listed 1830 Walton Co. Census, had: George W. Tomlin, b. 1833 Walton Co., m. Jane, b. 1837 Pulaski Co. [issue: Mary A. E., b. 1855; Matilda Ann, b. 1857; Isabell, b. 1858, Muscogee Co., Ga.]; and Pleasant Tomlin, b. 1831, farmer, w., Almeda, b. 1832 Putnam Co., Ga., listed 1860 Muscogee Co. Census. [issue: Sarah A., b. 1850; James, b. 1850; Jinca C., b. 1852; John, b. 1854; and Louisa, b. 1853, all Muscogee Co. Ga.].

II. Owen Tomlin, b. ca 1780, listed 1820 Putnam Census; 1830 Houston Co. Census; drew 1832 land lottery, from Marion Co., Ga., w., Mary J., b. 1772 Ga., wid. listed 1850 Marion Co. Census. His LWT dtd 8/12/1836, pvd 11/1837 Marion Co., Ga. Dau, Susan Rebecca Tomlin, b. 1812 Burke Co., Ga., d. 11/16/1879 Marion Co., Ga. m. 5/16/1829 David Ward Upton, listed 1840 Stewart Co. Census; 1860-70 Marion Co. Census, and had: George; Robert; William; Emily, Mahala; Laura Ophelia; and Josephine Upton.

III. John Tomlin, Sr., b. 1775/1794, listed on 1820 Burke Co. Census, drew in 1832 land lottery from Burke Co. His son, John Tomlin, Jr., also drew.
