Also sp. Wheless, interchangeably in records. Joseph Wheelless, his LWT dtd 4/16/1761, pvd 6/1761 Halifax Co., N. C., naming issue: John, James, Elizabeth and Joseph.

Joseph Wheelless m. Molley, his LWT dtd 11/14/1786, pvd 2/1787 Halifax Co., N. C. naming children: Christian Bruce, Sion (b. ca 1760), and Hardy.

Hardy Wheelless removed to Ga., d. 1823 in Jones Co. Wife, Lidda. Revolutionary War Soldier, listed on 1820 Jones Co. Census. Jones Co. DB O, P. 397, Hardy Wheelis deeds to his seven children: Hardy, Joseph, Archibald, Manning, Lafayette and Mary, 6/23/1831, 250 acres in 10th dist. of Jones Co., lot 105. In his Will he names his granddaughters, Emily Williams, Sally Wheelless, Elizabeth Bird and Sally Ross; also, sons, Eli, Sion and Matthew. Issue as follows:

I. Eli Wheelless m. Elizabeth Jackson 7/25/1800 Greene Co., Ga., listed on 1820 Morgan Co., Ga. Census.

II. Sion Wheelless, b. 1790, wife, Sarah, b. 1802. Listed on 1805 Ga. land lottery, Meriwether Co., 1820 Jones Co. Census, 1830 Monroe Co. Census and 1850 Meriwether Co. Census. He first purchased land in Meriwether Co. in 1847. Issue: R. C., dau., b. 1829 Monroe Co. Ga.; C. P., son, b. 1832; L. M., son, b. 1834; S., son, b. 1836; A., dau., b. 1838; A. C., son, b. 1840; E. J., dau., b. 1842; N. E., dau., b. 1844; and L., dau., b. 1833.

III. Matthew Wheelless. Wife, Nancy. Listed 1820 Jones Co. Ga. Census. His LWT dtd 2/16/1849, pvd 9/1849 Monroe Co., Ga., WB B, 1847-1865. Issue: Henry who m. Betsy Lord 12/12/1830 Jones Co. Ga.; Lucinda who m. Mr. Bothwell; Sarah; Martha and Mary.

V. Hardy Wheelless, b. 1789, d. 1857, m. Fannie Lumpkin. Lived Jones Co., Ga. 1820, m. Hannah Rimes 6/12/1806 Greene Co., Ga.

Abner Wheelless, b. 1769, d. 1849, aged 80, according to White's Statistics of Georgia. Abner came from N. C., lived in Meriwether Co., Ga. He m. Nancy, dau. of William Kimbrough. Abner lived in Greene Co., for in 1800 there is a deed dtd 1/15/1800 Jones Co. of Abner Wheelis of Greene

Co. to John Brown of Jones Co. Another deed of Abner Wheelless to John Brown dtd 5/14/1813 Jones Co. According to LWT of Thomas Kimbrough dtd 1825, Abner and Nancy Wheelless were living in Greene Co. that year. Abner was listed on 1830-40 Meriwether Co. Ga. Census, and Nancy listed on 1850 Monroe Co. Census, with her children, Sarah, Martha and Mary.

According to deeds in Hancock Co., dtd 1800 of Abner Wheelless to John Sledge, he lived in Hancock Co. Also, Greene Co. deeds dtd 1800, 1804, 1806, he lived in Hancock Co, and in 1809. Issue of Abner follows:

V. Thomas K. Wheelless, b. 1811 Greene Co., Ga., m. Lucinda Wyatt 12/23/1830 Meriwether Co., Ga. Listed on 1850 Meriwether Co. Census. A LWT recorded in Putnam Co., Ga., WB B, P. 30-31, of Thomas Kimbrough of Putnam Co. establishes that Thomas K. Wheelless was a son of Mrs. Nancy Kimbrough Wheelless, wife of Abner Wheelless:

"I bequeath unto Bradley Kimbrough, son of William Kimbrough, 192 1/2 acres of land...to my beloved wife, Frances, to Thomas Wheelless of Greene County...his mother, Nancy Wheelless...to my nephew, Thomas Kimbrough, son of William Anthony and Judy and all their children...to Thomas Slaughter, son of William Slaughter, deceased, have my man Greene after the death of my wife...to my nephew, Thomas Kimbrough of Putnam County to have Anthony and Julia and all their children...wife, Frances and Thomas Kimbrough of Putnam County and Thomas Kimbrough of Greene County to be executors." Dtd 5/16/1825.

Meriwether Co. Returns, Bk E, P. 40, Return of William Wyatt, gdn of Thomas Wheelless' children, 2/21/1859. Page 252: "The Return of William Wyatt, gdn of Phillip H., Sarah E., Mary E. Wheelless, Mrs. Thomas Wheelless' children."

Issue of Thomas K. Wheelless: Phillip H., b. 1843; Sarah E., b. 1845; Mary E., b. 1847; William, b. 1832 m. Harriett N.
