

WILKINS

Thomas Wilkins, b. ca 1700, his LWT dtd 4/25/1759 Halifax Co., N. C., pvd March Term 1762. His issue follows:

I. Thomas Wilkins. Elbert Co., Ga. deed dtd 10/1/1792, Nathan Jones and wife, Cartha to Thomas Wilkins, 45 acres on Falling Creek. In 1792, Thomas Wilkins was granted 150 acres in Richmond Co., Ga.

II. William Wilkins, gtd 250 acres headright in Richmond Co., Ga. in 1785, and again, 200 acres in 1788. Richmond Co. deed to Nathaniel Offutt to William Wilkins, 150 acres on Briar Creek, gtd 12/1787. William Wilkins wtd deed of Jacob Castleberry to Thomas Hamilton, Richmond Co. in 1788. William Wilkins d. Richmond Co., Ga. before 1789, sole extrx of est. being Elizabeth Chambers.

III. Robert Wilkins. Richmond Co., Ga. deed dtd 1789 of Robert Wilkins to William Thomas, Jr. of Pittsylvania Co., Va., 275 acres in Halifax Co., Va. Recd 1788 headright of 200 acres in Richmond Co., Ga.

IV. James Wilkins and his wife, Catherine, lived Hancock Co. Ga, however, before that were in Wilkes Co., listed on 1793 Wilkes Co. Tax Digest as owning 250 acres of land in Columbia Co., and 300 acres in Wilkes Co. He is also listed on 1794 Hancock Co. Ga. Tax Digest, owning 200 acres in Hancock Co. on Buffalo Creek, and in 1795, 225 acres Hancock Co. on Buffalo Creek, 50 acres in Hancock Co. on Buffalo Creek. 9/3/1807 he was granted 238 3/4 acres of land in Hancock Co. His LWT dtd 1809 in Hancock Co., pvd 5/2/1809, naming children, and "the child that my wife is now pregnant with." Filed WB F, P. 41-2.

The 1812 tax lists in Hancock Co. show Catharine Wilkins owning large tracts of land in sd county, and 6 slaves. Catharine Wilkins and her dau, Susannah Wilkins, united with Darien Baptist Church, near Linton, Ga., on 4/6/1813. There is a deed dtd 5/7/1817 between William McDowell of Jasper Co. and Catharine Wilkins of Hancock Co., exrs of LWT of James Wilkins, decd, to William Rushin of Washington Co. for 396 3/4 acres on Buffalo Creek in Hancock Co. On 3/12/1827, Catharine Wilkins sold to Jane Trawick a negro girl about sixteen, named Leah.

Mts. of Ct. of Ordinary, 9/3/1829, Hancock Co., shows receipts in full from William B. Knox; William Rushin; Susannah Ray; Jane Trawick; Bryant Hood; James Wilkins and Levina Wilkins, legatees of James Wilkins, decd, to Catharine Wilkins, extrx of LWT of said decd.

The Darien Baptist Church minutes for 12/26/1835 shows L/A gtd to Catherine Wilkins, Frederick Swint, Rebecca Swint, and Mary Brookins. Catherine Wilkins found on 1850 Census of Chambers Co., Ala., living with her grandson, John T. Ray, and dau., Susannah Ray. Catherine, b. 1780 Ga.

The wife of James Wilkins may have been Catharine Swint. She died ca 1852 Claiborne Parish, La. Issue of James Wilkins and wife, Catharine, follows:

IX. John Wilkins, b. ca 1730/1735 N. C., d. 1783 Wilkes Co., Ga. Micajah Williamson qualified as admr of his est. 9/18/1783, L/A also gtd to Mrs. Mary Wilkins. After his death, Mary m. John Foles 9/26/1792 in Columbia Co., Ga. John Wilkins first came to Ga. from Halifax Co., N. C., appearing in Wilkes Co., Ga. Ceded Lands. "John Wilkins, 12/7/1773 from North Carolina, with a wife, three sons and two daughters, from 16 years to 3 years of age." He was granted 400 acres on Fishing Creek in Wilkes Co., Ga., request made at Wrightsborough, Ga., the land located on n. fork, at Lempkey's Camp. Issue follows:

1. William Wilkins, was on 1793 Columbia Co., Ga. Military Roster. Died 3/1830 Columbia Co., Ga. In 1791 he registered his Mark and Brand in Effingham Co. He was Justice of Peace in Columbia Co. 1794, 1812, 1813; Senator from Columbia Co. 1812; elected Sheriff 1809-1811; Lt. Col. 1815; Colonel in 1819.

2. John Wilkins, b. ca 1755 N. C., wife, Sarah, who m. after his death, Thomas Low. When she died, her son-in-law, Thomas Douglas, was apptd admr. of her est. 11/2/1829 Wilkes Co., Ga. WB HH, P. 193, Sally Low leaves to her grandchildren, "sons and daughters of my son, Vincent B. Low, land whereon I now live and several slaves." She names her granddau, Barthenia McLendon, the wife of Simpson McLendon. Also names dau, Judith Simpson, and dau, Jane Douglas "slaves with the express condition that Peter Harris, son of my daughter, inherit them." Her LWT dtd 11/13/1822, pvd 7/3/1826, Wilkes Co. Her second husband, Thomas Low, d. 1806. Mts. of Inf. Ct. Wilkes, Co., 1798-1811, P. 272: "Jenny, orphan of Thomas Low, chooses Sarah Low, guardian." Page 271: "Vincent, orphan of Thomas Low, chooses Stith Barksdale and Sarah Low petitions to divide estate." John Wilkins was granted 500 acres in Wilkes Co. in 1788. Elbert Co. Ga. deed 3/10/1790, Robt Mosley and wife, Sarah, deed to John Wilkes, of Wilkes Co. Ga. 200 acres. John Wilkins, Revolutionary War Soldier, petitions for land, Warrant 821, resident of Wilkes Co., Ga., 6/21/1784.

After 1792, there is no further record of John Wilkins who lived in Wilkes Co., and it is believed he died around 1800, as his widow remarried about that time to Thomas Low.
