

WINGFIELD

John Wingfield, b. 1723 Hanover Co., Va., d. 12/3/1793 Wilkes Co., Ga. Southern Centinel and Universal Gazette dtd 12/19/1793: "Died at his seat in Wilkes Co. Dec. 3rd, John Wingfield, aged 70 years, leaving wife, three sons, 6 daughters, 39 grandchildren. He was born Hanover County, Va... settled in this State in 1783."

Wilkes deed 5/24/1790, John Wingfield, Sr. and wife, Frances, to John Wingfield, Jr., 650 acres, gtd to John, Sr. 1784 and 1785.

His Ann. Retn dtd 1798 mentions land in Jackson and Clarke Cos., Ga. His LWT dtd 3/10/1791, pvd 1/15/1794 Wilkes Co., Ga., leaving legacies to: Sarah Pettus, David Meriwether, Hope Hull for w. Nancy, Mary Terrell, Patsy Foster, Fanny Meriwether, Elizabeth Butler, Rebecca Darracott. Issue follows:

I. Garland Wingfield, his LWT dtd 6/8/1824, pvd 9/6/1824 Wilkes Co., Ga. names nephs., Stephen, Charles and John Pettus. And wife's son, Thomas N. Poulain. Garland Wingfield m. his cousin, Sarah G. Wingfield whose first husband was Anthony Poulain, decd in 1794 Wilkes Co., having issue: Thomas Noel Poulain.

II. John Wingfield, Jr. m. Mary Darracott, dau. of Thomas Darracott, per LWT of sd Darracott dtd 9/4/1792, pvd 12/19/1793 Wilkes Co., and his w., Elizabeth. John Wingfield, Jr.'s LWT names lands in Jackson and Clarke counties, pvd 3/8/1802 Wilkes Co., naming w., Mary; bro., Garland; issue, Garland, Overton and John. Div. of slaves dtd 1/19/1811 to widow, Mary and heirs: Patsy, now Simpson; Garland; Fanny; Elizabeth; Sally; Nancy; John L. and Overton. Issue follows:

IV. Rebecca Wingfield m. John Darracott, s. of Thomas. Inv. of Thomas dtd 12/30/1793 Wilkes Co. names Edward Butler, David Meriwether, Garland Wingfield and Peter Terrell, with John Darracott, admr.

V. Patsy Wingfield m. John Harden Foster. LWT of John dtd 4/21/1801, pvd 7/27/1801 Wilkes Co. Receipts given by John Harden Foster and John Darracott 1796, est. of John Wingfield. 11/10/1789, Wilkes Co., John Harden Foster and w., Patsy deed to Wm. Acree 500 acres on Broad River.

VI. Nancy Wingfield m. Rev. Hope Hull.

VII. Thomas Wingfield. 12/15/1785 Wilkes Co. Michael Cupp and w., Barbary deed to Thomas Wingfield of Va., land on Rocky Cr. His LWT dtd 7/21/1797, pvd 12/27/1797. John H. Foster and Peter B. Terrell to divide his land into three equal parts, for wife and children. Issue follows:

1. Samuel Wingfield m. Lavinia, dau. of Thomas Chivers, Sr., latter's LWT dtd 11/15/1809, pvd 7/2/1810 Wilkes Co. Charles Wingfield was admr of est. of Samuel 9/6/1821 Wilkes Co., paying Lavinia Wingfield and Charles Evans of S. C. for boarding mail carrier. Issue follows:

4. Molly Wingfield.

5. Fanny Wingfield. Orph. of Thomas Wingfield chooses John Butler as gdn 3/7/1803 Wilkes Co.

6. Thomas Wingfield, LWT 1/17/1820, pvd 1/9/1821 Wilkes Co., w., Elizabeth. Names bros., Charles and Samuel, and issue as follows:

a. Edward B. Wingfield, his LWT pvd 9/7/1829 Wilkes Co. naming bros and sisters.

b. Charles Ann Catherine Wingfield.

c. Virginia N. Wingfield.

d. Sophia H. Wingfield m. William A. Terrell 5/3/1825 Wilkes Co.

e. Elizabeth N. B. Wingfield m. John Porter 10/26/1826 Wilkes Co.

VIII. Sarah Wingfield m. John Pettus, s. of Stephen. John Wingfield asks that Garland Wingfield be apptd gdn of John, Charles and Stephen, sons of Stephen Pettus, late of Hanover Co., Va. 3/1789, in Wilkes Co.

IX. Elizabeth Wingfield m. Edward Butler having issue: Thomas, John, Joel.

X. Mary Wingfield m. William Terrell, s. of Peter, Peter's LWT dtd 8/22/1794, pvd 4/21/1795 Wilkes Co. naming dau., Fanny Wingfield Terrell, Edward Butler and three sons, Thomas, John and Joel. William Terrell gives bond for Virginia land "of which my wife had 1/7th part, re: est. of John Wingfield."

Thomas Wingfield, brother of John, Sr., also came to Wilkes Co. Ga. in 1783 from Hanover Co., Va., where he was exr of LWT of Thomas Garland of St. Paul's Parish 2/27/1731, pvd 4/5/1734, naming wife, Ann, and Peter, Robert, John, James and Nathaniel Garland.

7/24/1783, Wilkes Co., George Walton deeds to Thomas Wingfield, Sr. and John Grimes and John Wingfield, Jr. of Hanover Co., Va. 1150 acres on "The Ridge", adj. Washington, Ga. 5/11/1787 same co., Thomas and Elizabeth Wingfield deed to John Grimes 16 acres adj. Washington, Ga. The LWT of Thomas Wingfield, Sr. dtd 8/21/1799, pvd 7/22/1806 Wilkes Co., Ga., naming w., Elizabeth, and children. To son, "John, land left in Va. by my father." Issue follows:

III. Mary Wingfield m. Richard Worsham. Wilkes Co. deed 3/12/1789, Richard and Mary Worsham deed to Peter Bond 1000 acres, Wilkes Co.

IV. Milly Wingfield m. 1st John Grimes, his deed of gift dtd 10/2/1789, Wilkes Co., to children, i.e., Thomas Wingfield Grimes, John Grimes, Sterling Grimes, William Garland Grimes, and Lucy Grimes. She m. 2d Frederick Sims, s. of Benjamin, latter's LWT dtd 3/12/1799, pvd 2/26/1800 Wilkes Co., Ga. 8/1/1803 Wilkes Co., Benjamin Dickinson Sims, orphan, Richard Worsham apptd gdn; also Henry Pierce Sims, orphans of Frederick Sims, decd. Named as gr-ch. in LWT Thos., Sr.

V. Nancy Wingfield m. Mr. Griffin, having issue: Thomas, Lucy, John, Failing and William Garfield Griffin, named in LWT of Thomas Wingfield, Sr. as grandchildren.

VI. Sarah G. Wingfield m. Anthony Poulain, his est. admd. 12/1/1794 Wilkes Co., with Thomas and John Wingfield, Sec. Returns of Sarah G., admx, 7/20/1800 says her brother, John Wingfield has transacted business of est. John R. Wingfield was apptd gdn of her son, Thomas Noel Poulain.
