

James Wyatt, b. ca 1670 Va., removed to Edgecombe Co., N. C. DB OO, P. 260, sd co., James Wyatt to John Jones, 11/18/1760, 137 acres, a plantation on n.s. Beaver Dam Swamp, wit: Jacob Wyatt, Absalom Pauls, Nathaniel Whitehead. LWT dtd 2/10/1784, pvd 2/1785, Halifax Co., N. C., WB 326, P. 73, bequeathing to son, John, use of plantation; bequeathing to gr-son, Jacob, son of John, all personalty between sons, James and John. Issue of James follows:

II. James Wyatt, d. 5/1787 Halifax Co., N. C., WB 370, P. 129, dtd 2/16/1787, pvd 5/1787, naming w., Sarah, and issue: James, Christian, Sarah and Elizabeth, the latter not 21 yrs.

To Jesse, "the plantation I now live on containing 110 acres; also 300 acres in Halifax Co. on both sides of Green Creek Swamp." To dau., Christiana, 12 pds. when she becomes of age. "I lend my wife, Sally, one-third of all my lands, slaves, during her life, or until she marries." To Thomas, "all my lands, except his mother's one-third, which he is to possess after her decease." Daus., Betsey and Sookey, one negro each. Edgecombe Co., N. C. DB 3, P. 104, 2/23/1776, Jesse Wyatt of sd co. to Nathan Whitehead, 345 acres of land adj. James Wyatt and Nathan Whitehead. DB 3, P. 110, 5/3/1776, Jesse Butt, Roady Butt, Jesse Wyatt of Halifax Co., to Thomas Nicholson, 172 acres n. bank of Beaver Dam Swamp. Issue of Jesse follows:

The gr-grandfather in following sketch should be "Thomas B. Wyatt" — Memoirs of Georgia, V. II, P. 435-6, "I. T. Wyatt, planter, Jasper Co., Ga., only child of W. H. and Cynthia (Winfrey) Wyatt, was born in Jasper County, September 28, 1835. His great-grandfather, John Wyatt, was a citizen of Virginia during the revolutionary war, a soldier in the patriot army, migrated to Georgia, and settled in Clarke county in 1802. He afterward moved to Butts county, Ga., where he lived until his death, which occurred at the advanced age of ninety-nine years. Mr. Wyatt's grandfather, Thomas Wyatt, was born and reared in Clarke county, whence after his marriage to Miss Nancy Wooten, he moved and settled near the line of Jasper and Morgan counties, where he reared his family, and died in 1857. His children were: John W., planter, Jasper county...; William H., father of the subject of this sketch; Nancy A.; DeGraffenreid, and Tabitha. Mr. Wyatt's father was born in Morgan county in 1812, but lived all his

life in Jasper county... "Ike Tom" Wyatt he was called... Mr. Wyatt was married in Monroe county, Ga. to Miss Mary A. Sullivan, born and reared in Monroe county, daughter of Hilliard Sullivan, a North Carolinian by birth. This union... has two children: William H., planter, near the homestead, and Cynthia, widow of John Christian, living with the old folks at home...."
