

## YOUNGBLOOD

Benjamin Youngblood came from Granville Co., N. C. into Edgefield Co., S. C., then Richmond Co., Ga. where he was decd in 1784. Wife, Martha. The first record we find of this family in Edgefield Co., S. C., is a deed dtd 1/27/1774 of Peter Youngblood "of Granville Co." to John Frazier, 100 acres, s.s. Beaverdam Cr. of Savannah River, signed Peter and Mary Youngblood. Richmond Co. Ga. DB IF, P. 37, 4/23/1784, Peter Youngblood and John Youngblood, heirs of Benjamin Youngblood, decd, to Joshua Grinage, 100 acres which was gtd sd Benjamin Youngblood in 1775, with Martha relinquishing her dower. 4/23/1784, Peter and John Youngblood, heirs of Benjamin, decd, to Joshua Grinage, 100 acres, St. Paul's Parish. Issue of Benjamin follows:

I. John Youngblood m. Ann Tarvin 9/6/1794 Columbia Co., Ga. 8/8/1801 Columbia Co. Ga. deed, John Youngblood and w., Anna, to Abraham, 124 acres, includ. plantation and dwelling house adj. Benjamin Youngblood and Jacob Youngblood on Little Kiokee Cr. Another Columbia Co. deed, 4/11/1795, John Youngblood and w., Ann to Wm. F. Booker 100 acres, Little Kiokee Cr.

II. Peter Youngblood, Sr., decd 1788, w., Susannah. Richmond Co. Ga. DB IG, P. 58, 10/21/1788, Susannah Youngblood, wid. of Peter, decd, and Samuel Youngblood, Joseph Youngblood, William Wilson and wife, Rebecca, Cain Gentry and wife, Liddy, Lewis Youngblood, and Sarah Youngblood, Susannah and Margaret Youngblood of same place, 100 acres. Richmond DB IG, P. 103, 12/11/1775, Jacob Jones and Elizabeth, wife, of St. Paul's Parish, to Peter Youngblood, planter, 100 acres. Columbia Co. deed of gift, 11/27/1777, Peter Youngblood, Sr. of Richmond Co., to sons, Abraham and George, 200 acres Whiteoak Cr. to include plantation. Peter Youngblood, now decd, 5/6/1794. /s/ John Youngblood, Lewis Youngblood, et al. George Youngblood appears and deposes that his bro., Abraham, is now decd, and was possessed by above tract destroyed by fire. Issue follows:

1. Abraham Youngblood. Columbia Co., Ga. ests 3/8/1799, George Youngblood issued ltrs adm. est. of Abraham (decd by 1794). Abraham m. Amey McNeill 3/1/1787 Richmond Co., Ga.

2. George Youngblood m. Nancy Simpkins 10/24/1788 Richmond Co., Ga., dau. of Arthur Simpkins. George lived Edgefield Co. S. C. 1797, as evidenced by deed, Columbia Co. 4/16/1797, George Youngblood of Edgefield Co. S. C. to Jesse Offutt, 10 acres ss. Whiteoak Cr., orig. gtd to James Neal and sold to Peter Youngblood and by him, deed of gift to George Youngblood.

3. Peter Youngblood, Jr. Greene Co. Ga. DB DBI, P. 343-344, 2/14/1789, Peter Youngblood of Edgefield Co., planter, to Howel Harris, 575 acres, Washington Co., now Greene Co., gtd 2/22/1785. Columbia Co. Ga. deed 1/12/1797, Peter Youngblood of Richmond Co., to James Culbreath, 300 acres, Trading Path, gtd Peter Youngblood 8/6/1763, on Fortune Branch. (this grant prob. relates to Peter, Sr.)

4. Samuel Youngblood lived Hancock Co., Ga. 1794

5. Joseph Youngblood.

6. Rebecca Youngblood m. William Wilson.

7. Liddy Youngblood m. Cain Gentry, s. of Elisha Gentry, (the latter's LWT dtd 9/3/1803, pvd 6/4/1804 Greene Co., Ga.)
8. Sarah Youngblood m. Edward Hagin 1/8/1807 Richmond Co., Ga.
9. Susannah Youngblood,
10. Margaret "Patsy" Youngblood m. James Cone 1/8/1807 Richmond Co., Ga.
11. Lewis Youngblood, his LWT dtd Edgefield Co., S. C. 2/11/1822, pvd 2/23/1822, w., Mary, naming issue: Abner, eldest, Gideon, Thomas, Basil (m. Ann Fleming 12/26/1833 Edgefield Co. S. C.), William, Sarah, and Catherine.

Others in Columbia and Richmond Cos. were Jacob who m. Lavinia Ashe 5/9/1798 Columbia Co.; Benjamin, b. 10/20/1773 Richmond Co., Ga., d. 1/15/1860 Marion Co., Miss, m. Susannah Collins 11/20/1794 Richmond Co., she b. 5/16/1775 Edgefield Co. S. C., d. 11/19/1866 Marion Co., Miss., dau. of Moses and Hannah Willis Collins. Joshua who m. Catherine McNeill 5/30/1789 Richmond Co., Ga., Catherine mentioned in deed of Anderson Crawford to Zach. Sinquefield, Columbia Co., Ga., 5/19/1794, 150 acres Saluda River, orig. adj. Catherine Youngblood.

A branch of the above family removed to Hancock Co., Ga. by 1794, as evidenced by deeds of James Youngblood, Samuel Youngblood and wife, to Nathan Youngblood; and James Youngblood to Arthur Youngblood, and there in 1808 when further deeds were made. In 1830, Arthur, Isaac, James and Thomas are in said co, and in 1850 Frances, b. 1770 N. C.; Thomas, b. 1799 Ga.; Nathan, b. 1770 N. C.; and Green, b. 1800 Ga., all in Hancock Co. The Hancock Co. group appear to be descendants of Samuel Youngblood, s. of Peter, Sr.
