Three other daughters; Mary McIntosh, Amelia Ellen, and Martha L. J., were

apparently born during the eight year span between Laban T. and Barney.

Two, Amelia Ellen and Martha L. J. both died in childhood while Mary

McIntosh had married prior to the 1850 census. ®2

A.J. Austin deeded land to George W. Helms on 28 Aug 1837: 33 D.E. 1-21. 149. (p26, ®5)

A.J. Austin deeded land to Seaborn J. Austin 1838: D. 1-4 1.115 (p26, ®5)

Names of patrons of schools of Chatahoochee Co, GA, in 1860. A.J. Austin had 6 children in school (p71, ®5)

He and wife were pioneer settlers at Bald Hill (Chatahoochee Co) in 1829. He

helped to cut out a road toward Columbus. Before this there were only

horse paths/trails to Mobile and later Fort Mitchell. A legislative act of

1841 refers to Allen Austin's residence at Bald Hill as an election precinct (p129, ®5).

The Cusseta-Columbus Road crossed the Federal Road near Coleman's (Ten Mile

House) on lot 218, 6th D (District). This was known as the Bald Hill Road in

all early records. It was laid out about 1830 when Dr. Allen Austin and

other early settlers began clearing the wilderness. The records of Muscogee

for said order be named by all parties (signed) John Bonnell, John C. Austin,

and C. A. Austin. It is ordered that James B. Huff, Wright McCook, Mark A.

George, A. J. Austin, and Willis C. Holtfree, holders of said Co do proceed

on first Monday to make a distribution of estate of Augustus B. Austin. Five

minor children of A. B. Austin entitled to years support, viz. Helen A.,

Sarah L., W. J., George W., and Caroline choose Seaborn J. Austin, Guardian.

A. J. Austin and George W. Helms his security (p290, ®5).

Dear Bob:

I have worked at length with his genealogy, trying to link the Muscogee-Chattahoochee Co. Austins to those in Pike Co., Alabama.

First, let me say that I thoroughly researched Muscogee and Chattahoochee Counties, as well as searched for bible records, militia, local histories, genealogies, etc. at the Georgia State Archives.

Here are my conclusions -

WILLIAM A. AUSTIN was born 3/9/1776, died 8/17/1850 Muscogee Co., Ga. I searched at

length to find any kind of an estate record in Muscogee Co. for William A. Austin. Chattahoochee

Co. was taken from Muscogee in 1854, and that is where the family showed up for that time

period. So, the residence must have been in that portion of Muscogee which later became

Chattahoochee. The Chattahoochee Co. Records did not reflect anything for him, either. I thought

some Returns, Sales, etc. might be filed in Chattahoochee, but no luck here. I am quite interested

to see who received funds, etc. from his estate...that's what we need.

His wife, AMELIA HOWARD b. 1781 Columbia Co., Ga., d. 1864

Chattahoochee Co., Ga. I

also searched for an estate record for her, without luck. In 1854 she deeded her Chattahoochee

Co. Land to Vince Averett, with her sons, Allen J. Austin and son-in-law, George W. Helms as

witnesses. She must have then moved in with her son-in-law, George W. Helms. After the death

of her husband, she lived with her son, Allen J. Austin, and was listed on the 1850 Chattahoochee

Co., Ga. Census as follows:

proof for obvious reasons.

What I tried to do was to follow the movements of the children, looking at their estates and deeds to see the correlation between family members. I just don't know why Laban Turk Austin is not mentioned anywhere, except for the fact that after he married in Crawford Co., Ga., then moved on over to Pike Co., Alabama, before 1830.

I searched to see "who else" he might be a son of, and came up with no one. I thought he might be a first-cousin to the children of William and Amelia Austin, but was unable to locate anyone of that age range. The similarity of names, marriages in Crawford Co., Ga., all point to William A. Austin as the father. Even Augustus B. Austin, b. 1812, was 1854, according to a deed, a resident of Barbour Co., Alabama, then in 1855, a deed indicating that he was a resident of Muscogee Co. This family clearly had Alabama relatives!

In conclusion, I have found no record to absolutely prove that Laban Turk Austin was a son of William A. Austin. You mention the Turk's. They resided in Meriwether Co., which is an adjoining county to Muscogee, near the Alabama border. The name "Laban Turk" is, no doubt, an ancestor of yours. There was a Laban Turk in Georgia. He resided in Jones Co. and was named in the LWT of Peter McFarlin, Sr. Dated 2/28/1816, probated 1/16/1822, Jones Co. Will Book A, who left a bequest to "Laban Turk, in right of his wife, Lucy" (Lucy, being a daughter of Peter McFarlin). I did not locate a LWT for Laban Turk in Jones Co....perhaps he moved on to Meriwether Co. where Henry Turk was found in 1850. Turk's also resided in Baldwin County, 1830's. The following marriages from Baldwin Co. - John Turk-Eliza Edmondson 6/22/1837, Theodocius W. Turk-Martha J. Hines 7/3/1845 and William J. Turk to Mary Dean 8/2/1831. You remember that William A. Austin resided briefly in Baldwin Co. I did not locate any Jones Co. marriages for Turks.

The LWT of Theodocius Turk dated 10/1804, probated 3/10/1805, Baldwin Will Book B, page 54 named wife, Velinda. Sons: John, Laban, Theodicius, Thomas. Daus: Nancy Turk, Martin Horton. Grandson: Theodocius Turk.

This sets Laban Turk as a potential paternal or maternal grandfather.

Perhaps Laban Turk removed to Alabama after 1822, I haven't traced him after that time. Obviously, Laban Turk a forebearer of your Laban Turk Austin, as well as Allen Jefferson Austin. My guess is that Laban Turk and Allen Jefferson Austin were brothers, however, they could have been first-cousins. However, the only Austin old enough to be either of them's father was William A. Austin.

There was a Robert Turk who died 1772 in Augusta Co., Virginia. This may be from whom the Georgia Turks descend. Actually, there seems to be one or two Turk families in Georgia during the early days.

If you wish to pursue this further, I suggest researching Meriwether Co. records for Austin/Turk families. Then, tracing Laban Turk's origins. Perhaps during that process, further information could be found to help fill in the gaps. I don't know where this would take us, but obviously Laban Turk is a family name and these two boys were
