Avery/Avary of Columbia, DeKalb & Warren Counties

John Avery was born in Virginia, died in Columbia County in 1817 where he received a Land Grant for his services as a Revolutionary War Soldier. John Avary was granted a large tract of land on the Savannah River in Columbia County on 12 January 1798. His LWT dated 25 January 1813, probated 9 July 1817 in Columbia County. He named his children as follows: Elizabeth M. Smith, Milly Farrer, Harbert Avery, Archer Avery, Asa Avery and John Avery. He married Mary Loggett. His pension application indicates that he had two sons, Archer and Isaac. The LWT of Asa Avery in Columbia County indicates that he had a brother, Archer Avery and a sister, Patsy Welbourn.

Columbia County Deeds

1 January 1799. Robert Flournoy of Jefferson County to John Avary for \$370.00, 244 acres of land on the waters of Loyd Creek, it being part of my "Mountain Tract", lying to the right of the road from Augusta and Lamkin's to Jennings, bounded by Lamkin, Courson, Lambecker, Parkes and Meriwether.

- B. Phoebe Avary married Madison Avary on 28 July 1838 in Columbia County. Her LWT dated 23 January 1880, probated 3 May 1886 in Columbia County, naming her grandchildren: Phoebe T., Mercer I., William Madison and Irene Flanigan; father of children, James Flanigan. Son: Charles B. Avary.
