

## Lindley of Cobb County

John Lindley of Pendleton District, South Carolina deeded to Enoch Garner of the same place on 5 March 1790, for pounds, 150 acres, being part of 465 acres granted to Elijah Owens on 4 September 1786 and conveyed by said Owens to Thomas Standley and from said Standley to the said John Lindley, being on the north side of Big Creek. Also, 6 acres of another tract joining the above tract on the north side of Big Creek. The LWT of John Linley was dated 9 September 1790 in Pendleton District, indicating that he was a yeoman. "All of my property, real and personal, to sold, except what is deemed necessary for the use of my wife and children, and the monies to be used to discharge of my debts and the residue of said property to be equally divided between my wife, Sarah Linley, and my unmar children. Executor: William Pyle, Jr. Executrix, wife, Sarah Linley. Proved by the oath of John Robinson on 11 November 1790. On 8 November 1794, William Pyle of Pendleton County, South Carolina, Executor of the Estate of John Lindley, deceased, to Sarah Lindley of the same place, Executrix of said Estate. Whereas: John Lindley, late of Pendleton County, South Carolina, yeoman, at the time of death was possessed of land and other estate and by his LWT dated 9 September 1790, directed it to be sold at public sale (the household furniture excepted) by William Pyle, Executor, and Sarah Lindley, Executrix, and Whereas: a public sale was advertised and carried into office 11 December 1790, which was cryed and conducted by William Farris, employed for that purpose, and Whereas: Sara Lindley, being the highest bidder, paid 30 pounds for 260 acres, being part of 400 acres granted on 6 March 1786 to John Martin and conveyed on 17 November 1786 to George Pearce, who conveyed it on 26 September 1787 to said John Lindley.

Jonathan Lindley is presumed to be one of the children of John and Sarah Lindley. He was born 1772 in South Carolina, and died after 1850 in Powder Springs, Cobb County, Georgia, buried in the Baptist Cemetery. He married Nancy Blair (died 27 May 1840), the daughter of Johnson Blair. They were residents of Pendleton District, South Carolina. Issue:

- I. James Lindley, born 9 December 1797 Pendleton District, died 29 December 1886 in Powder Springs, Cobb County, Georgia.
- II. Ruth Lindley, born 1800 in Pendleton District.
- III. Lettie Lindley, born 1803 in Pendleton District.
- IV. Jane (Jennie) Lindley, born 1804 in Pendleton District, died 30 July 1873 in Walton County.
- V. William Lindley, born 1806 in Pendleton District, died 1842 in Walton County, Georgia.

VI. Jonathan Lindley, born 22 February 1808 in Pendleton District, died 5 September 1868 in Cobb County. He married Milley Henry on 18 November 1827 in Walton County.

VII. Thomas Lindley, born 16 January 1810 in Pendleton District, died 8 July 1882 in Powder Springs, Cobb County.

VIII. Elisha Lindley was born 25 January 1816 in South Carolina, died 12 October 1876 in Powder Springs, Cobb County. He married Jane Thomas Scott in 1839 (born 1813 in South Carolina). Issue:
