

## Trammell of South Carolina & Upson County

Thomas Trammell, the son of Daniel Trammell and his wife, Elinor (Burke) Trammell, was born 1747 in South Carolina and died on 22 September 1823 in Upson County, Georgia. During the Revolutionary War, he was a resident of Union District, South Carolina, and served as a private in South Carolina, Capt. Hughs, Capt. Dickson and Capt. Trammell's Companies, Colonel Brandon, Colonel Roebuck's South Carolina Regiment. He enlisted during the spring of 1780 and served throughout the war. He married Mary Turner on 21 December 1775 in Union District, South Carolina. Mary died 28 August 1851 in Chambers County, Alabama and was buried in the Emory Chapel Cemetery. Issue:

V. Farr Harris Trammell, born 23 June 1790 Georgia, died 2 April 1868 in Chambers County, Alabama, buried in Fredonia. He married Sallie Hagood on 20 August 1812 in Clarke County. Residents of Walton County in 1820.

VI. Betsy Green Trammell, born 11 December 1792 in Georgia, died 9 September 1833 in San Felipe, Austin County, Texas.

VII. Nancy Trammell, born 16 January 1796 in Georgia.

VIII. Drakeford Lee Trammell, born 8 November 1797 in Georgia.

IX. Milcah Trammell, born 15 April 1801, died 29 October 1837.

Revolutionary War Pension of Thomas Trammell, W11655, Georgia, Upson County, application of Mary Trammell dated 20 April 1846. The affidavit of William Turner in Henry County, Georgia dated 21 March 1846, aged 68, stated that the said Turner removed with his father from North Carolina to Union District, South Carolina in 1773 and afterwards became acquainted with Thomas Trammell. In December of 1775 deponent was present at the wedding of Thomas Trammell, wedding dinner and marriage, and that the said Trammell and his wife, Mary, lived together as man and wife; that said Trammell was a resident of Union District until the fall of 1784 and the latter part of the spring of 1780 Trammell left his home to join the army.
