Deed Book I, page 70. 16 May 1806, Daniel Zuber to the trustees of the University of Georgia. Daniel. Zuber, Barnabas Arthur and Mathew Varner to be bound to the trustees for \$614.00 for payment of \$307.00, \$76.25 due 25 December 1817 and each year until 25 December 1820. Daniel Zuber's security is the lot in the 500 acre tract on Falling Waters which Daniel Zuber bought from the trustees; 100 acres, Lot 46.

Deed Book I, page 27. 17 May 1816. Emanuel Zuber of said county to the trustees of the University of Georgia, Emanuel Auber, Mather Varner and Hail Maxey to be bound for \$900 for payment of \$550, \$112.50 due on 25 December 1817, and \$112.50 due each 25<sup>th</sup> December until 25 December 1820. Emanuel Auber for \$450.00 and security, Lot in the 5000 acres on Falling Creek, bought from the trustees, 100 acres, Lot 49.

Deed Book C, page 474. 17 November 1800. Thomas Lambert and his wife, Elizabeth to Abraham Zuber for \$115.00, land on Little River.
