

Will of George Lang

In the name of Almighty God, I, George Lang, Superior of the State of Georgia and
County of Camden & Planters, feeling deeply impressed,
with the uncertainty of this life and the certainty of
death, do make and publish this my last Will and Testa-
ment; hereby revoking all and every Will heretofore made
by me, as to such worldly estate as it hath pleased my
God to have entrusted me with; and do dispose of the same as
follows: After my just debts are paid, I give and bequeath
only my beloved wife Mary Lang one full and equal share
or portion of all my property both real and personal dur-
ing her natural life, after death I do direct that her said
share or portion of property shall be equally divided be-
tween all of my children and heirs of my body, that then
may be living, having the following named children, and
being, namely: Edmund Lang, Emily Tompkins and the wife
of Robert Tompkins, now residing in said State & County
of said name, George Lang Junior, Henry R. Lang,
Willie Lang, Charles Joseph Lang and Sarah Mary Lang
or to them that may be living at the death of my beloved
wife Mary Lang, and I further wish and be direct that
if any of my said children die, without issue or heirs
of their bodies, then such share of said deceased child
shall be equally divided between them that may then
be living or their heirs or issue, I also wish and be direct
that before any of my property shall be divided,
that the sum of seven hundred dollars be paid over
to my son Henry R. Lang, One thousand & paid to Willie
Lang, One thousand to Charles Joseph Lang and one
thousand, to Sarah Mary Lang This being conveyed
to them by their friends the late R. J. Tompkins interest ad-
ding to the said, these several amounts to be paid to
the four last named children to be in cash or property
as my Executor herein after named may deem best.

For all interested in my estate, than the remaining
 portion of my estate shall be equally divided as above
 stated between my wife Mary Lang and all my
 children and heirs of my body as shall be agreed
 upon and as may be appointed Robert Tompkins
 and the trustees of my daughter Emily Tompkins
 shall and doing by her husband and son of my brother Isaac
 Lang of the County of Camden, by Executors
 of said estate and County of Camden, by Executors
 of this my last will and testament in trust for the parties
 above named.

In witness whereof I have hereunto set
 my hand & affixed my seal in the said State and
 County of Camden this my last will and testament
 was ~~then~~ written in one sheet of paper on this Twentieth
 day of September, And I declare that I am then
 Eighty three years and forty two, single person and
 delivered by the said testator as my last will
 and testament in presence of persons who have remained
 and subscribed our names as witnesses in his presence
 and in the presence of each other.

 written, signed, sealed, and subscribed by the said
 testator, and that the same was
 sworn to and subscribed, before me, in open Court
 July Term 1873.
