State of Georgia } I Nathan Atkinson of the
Camden County } State and County aforesaid
do make and ordain this my last Will, and Testa-
ment in manner and form following -
Item I do give and bequeath unto my Son John
Atkinson his Heirs and assigns for ever the -
following Tracts of Land to wit: viz. Boston
Pachols, Simas, Chargo, Chen, Pink, China -
William, Diancas, Boston, Lint, Kelly, Grace, Sophia
Long, Rose, Frank, Lucy, George, Harry, Amy,
his wife and Betty and Lucy his children
Sack Cambo, Lohoses I also give him one
Heather Bed and Furniture.

Item I do give bequeath and devise unto my Son
Alexander Atkinson his Heirs and assigns for
ever all that Plantation or tract of Land
called Black Hammock whereon I now live
containing about Seven Hundred Acres with
all the Plantations belonging thereto to him and his

That it is my will and desire that my Executors
use their discretion as to the Disposal of my Son
Edmunds et al. as provided they give him a
liberal Education as far as the first Degree
and a Knowledge of the Principles of the Law be-
ing also my desire that the Negroes Willed to my
Son Edmund be divided to him on the first day
of January next preceding his arrival of age
That it is my will and desire that all my goods
and other property of what description soever
be put up in suitable lots and be divided as
equally as possible amongst my Children
To wit: John & Elizabeth and appoint my Sons
John & Thomas and Alexander & Thomas & Mary
Executors of this my last Will and Testament
and do hereby revoke and disannul all and
every former Will and Testament by me made
ratifying and confirming this also my other
to be my last Will and Testament in Writing

this 17 day of March in the year one thousand
eight hundred and sixteen
