Last Will and Testament of John Allen Dempsey,

I, John Allen Dempsey of said State and county being of sound and disposing mind and memory do make this my last will and testament.

Item 1. I wish my Executor as soon as possible after my death to pay my debts, if a sale of property shall be necessary I wish him to select for sale enough of my personal property that which can be most advantageously used for that purpose and I authorize him to sell the same at public or private sale as he may see fit.

Item 2. I give to my beloved wife Susan Elvira Dempsey the following property.

To-wit; land lot number Eight Hundred and Ninety (890) also land lot number Eight Hundred and Eighty nine (889) each lot containing forty acres, each more or less all of said land lying and being in the 18th. District and 2nd. Section of Douglas County Georgia. the above described land shall be exempt from levy and sale by virtue of any process whatever under the laws of the State, nor shall any valid lien be created thereon, but it shall remain for the use and benefit of my beloved wife, Susan Elvira Dempsey during her life time and at her death to be divided as follows.

Item 3. After the death of my beloved wife Susan Elvira Dempsey I give to my daughter Anna Dempsey McLarty (10) Ten acres of land off the entire West side of land lot number Eight hundred and Ninety (890) said Ten acres to be got the same breadth or width clear across the west side of said land lot; Said land lot being in the 18th. Dist. and 2nd. Section of Douglas Co. Ga.

Item 4. I give to my daughter Kate Dempsey Latham the remainder of land lot number Eight hundred and Ninety (890) that is all that remains of said land lot after the Ten acres given to Anna Dempsey McLarty is cut off; said lot of land being in the 18th. Dist. and 2nd. Section of Douglas Co. Ga.

Item 5. I give to my daughter Kate Dempsey Latham (10) Ten acres of land off the entire South side of land lot Number Eight hundred and Eighty Nine (889) said Ten acres to be got the same breadth or width clear across the South side of said land lot; Said land lot being in the 18th. Dist. and 2nd. Section of Douglas Co. Ga.

Item 6. I give to my daughter Anna Dempsey McLarty the remainder of land lot number Eight Hundred and Eighty Nine (890)

that is all that remains of said land lot after the Ten acres given to Kate Dempsey Latham is cut off; Said lot of land being in the 18th. Dist. and 2nd. Section of Douglas Co. Ga. the above named Tracts of land is bounded on the west by the land known as the Dick White Land, on the South by the land of Mrs. Ida Farmer and Mrs. Minnie Memphis (on the East by the land of Peter Lewis (on the north by the land of Jim Strickland and Tom Strickland.

Item 7. I will that all of the land that I have given to my Daughter Anna Dempsey McLarty shall be hers for her natural life and that at her death it shall become the property of her children and shall not be subject to any debt or lien whatever; nor shall not be sold for any debt any person shall make or contract, and that the title shall remain in her and her children for their use and benefit

Item 8. I will that all of the land that I have given to my daughter Kate Dempsey Latham shall be hers for her natural life and that at her death it shall become the property of her children and shall not be subject to any debts or lien whatever; nor shall not be sold for any debt any person shall make or contract, and that the title shall remain in her and her children for their use and benefit

Item 9. I will that if there is any money left at my death, after my Doctor bill burial expenses are paid I will Ten dollars to my son J.W. Dempsey also I will Ten Dollars to my grandson James Allen Dempsey and the remainder to my wife Susan Elvira Dempsey

Item 10. I do hereby appoint my son J.W. Dempsey Executor of this my last Will
